A Thoroughbred Racing Club was fanned in York in 1843. It was called the York Jockey Club. It commenced racing on its' present site in 1846 on land vested in the club for that purpose. An area of some 50.5 Ha. The rent was one peppercorn per year to be paid on demand on the 25<sup>th</sup> of March each year to the Sovereign or a representative of the Sovereign. In 1888 the land was leased. The rent was one shilling per year, and a race meeting was to be held at least once every two years. In 1920 the club was granted the land freehold with a *Fee Simple Title*. York is located 98Kilometers west of Perth.

#### Terms o(Re(erence

### (a) the effectiveness of the operations of R.W. WA.

RWWA came into being mainly due to agitation by racing industry stakeholders who felt that the WATC had become dictatorial in their attitude towards racing in WA. Their policies pointed towards the metropolitan club, along with Pinjarra and Bunbury in a lesser role, as dominating racing in WA.

I was also felt generally that racing in Western Australia had out- grow the WATC and that a body dedicated to administering the racing industry in Western Australia should be formed and combined with the wagering arm of the industry the TAB.

The effectiveness of the operations of RWWA have been compromised to a large extent by them adopting the policies of the organisation they were to replace, but who still appear to wield significant influence. Naturally RWWA in its early stages would have sought some guidance from the body previously charged with controlling racing in W.A. But this should have only been in matters of administration as RWWA had conducted in depth consultation with the industry. This should have provided grass roots information and enabled RWWA to establish policies in keeping with the expressed needs of the industry.

The WATC in applying its rationalisation policy caused the York and Beverley clubs to amalgamate. Northam and Toodyay were given the same ultimatum. Toodyay refused to join with Northam, and had their race dates taken from them As a consequence Toodyay became defunct. Northam was even under threat. The WATC continually refused RDT funding to York and adopted *a wither on the vine* policy as they did not want to be seen to be closing York down.

The government gave RWWA \$20M to distribute to provisional and country clubs. York did not receive a cent.

Esperance, Camarvon and Port Hedland all received \$150k respectively. Some clubs received over \$1m.

York applied for a grant of \$12,100 to pay for a much needed grass mower to provide flexibility in its track maintenance schedule. The Grant was refused as it was back dated 3 months.

In 2008 RWWA announced it was giving the WATC \$2.4m to replace funds it had expended in 2003 and 2004 on track maintenance at Belmont race course and because they had received none of the \$20m.

The WATC was continually challenged re the disparity between mid week Perth stake money and provincial stake money.

Under RWWA this disparity is continued.

Although the WATC only generated 68% of the total turn over and WAPTRA 32% WAPTRA had to surrender 4% to the WATC for "first charges" and a further 6% to the Country Racing association. Thus received 22% out of 32%

Today under RWWA the WAPTRA surrendered \$5.16m. in the 2007/08 season. Of this the WATC received \$3.68m (although they no longer pay the first charges) Other TAB clubs \$729,551

CRA. \$742,800

Although on page 69 of the Act subsection 2 does say "that the balance of the funds are to be paid or credited by RWWA in such amounts as it determines" This is qualified by subsection 3 on page 70 where it states that "RWWA is to use its best endeavours to ensure that the amount paid or credited to any racing club under subsection (2) in any racing year is not less than the revenue, after taxes and expenses are deducted, generated from wagering conducted by RWWA on races conducted by that race club during that year."

There is no mention of the C.R.A. after the 31st of July 2006. This is the date that the new distribution regime comes into affect as mentioned above.

#### (b) the needfor the continuation of the operations of RWWA

Overall the concept of the formation of RWWA and the intent of the Act as spoken of by many members of Parliament during the Committee Stages and formal debates will ultimately prove to be of benefit to the racing industry in Western Australia. It is difficult to legislate against human nature and frailties. After five years (5) some fine tuning will of course be required.

We submit the following for your consideration.;

- 1. There is an urgent need for some right of appeal to some independent body or entity. There is no right of appeal except to RWWA. The act is watertight in granting RWWA complete autonomy.
- 2. RWWA should not be able to consult with individual clubs. This is divisive by its very nature.
- 3. All matters dealing with the provincial clubs should be through the parent body WAPTRA.

- 4. WAPTRA should have the power to veto, on request by a member club any changes as proposed by RWWA which might affect that club. These requests can be singular or by any number of clubs in nature.
- 5. WAPTRA may consider the complaint as being frivolous in nature and decide not to pursue it.
- 6. WAPTRA can demand a meeting with RWWA within two weeks to address the Request. Should there be no agreement reached then both parties, within two weeks shall put their case to a neutral arbiter who shall make a judgement. There is no appeal.

Of course RWWA will see the appeal and veto as an erosion of their powers and will say that this will affect their capacity to act independently and without restriction. But the up side is that RWWA would need to act in a more circumspect manner if it knew it was open to a legitimate challenge. It would need to liase more closely with WAPTRA and this would be a plus for both parties.
