*Financial Agreement Act (19 Geo. V.)—*

An Act to approve an agreement between the Commonwealth of Australia and the States of New South Wales, Victoria, Queensland, South Australia, Western Australia, and Tasmania concerning the adjustment of the Financial relations between the Commonwealth and the States, and for purposes incidental thereto. Introduced by the Premier (Hon. P. Collier), 12th June, 1928. Reserved for Royal assent.
