# MINES REGULATION AMENDMENT BILL.

Read a third time, and passed.

SEATS FOR SHOP ASSISTANTS BILL. Read a third time, on motion by Hon. F. M. STONE, and passed.

## · FISHERIES BILL.

RECOMMITTAL.

Order read, for the third reading. Hon. F. M. STONE moved that the Bill be recommitted for amending Clause

It would be better to strike out the words "with a seine net," in lines 1 and 2, and then the Bill would provide that no person should fish with a seine net unless he had a license. The object was that the inspector should be able to know who had seine nets which were used in shallow waters and in estuaries. The last paragraph stated that every person who caught fish in Western Australian waters for sale with a seine net except as aforesaid, without being licensed, or employed for that purpose another person who was not so licensed, should be guilty of an offence; but there was no penalty He had moved that the stipulated. latter part of Clause 4 be struck out, but it was still in the Bill.

Motion put and passed, and the Bill recommitted.

#### IN COMMITTEE.

Clause 4: Fishermen fishing for sale to be licensed:

Hon. F. M. STONE moved that the words "with a seine net" after "sale," in line 1, be struck out; also that after "sale," in line 2 of the last paragraph, the word "or" be inserted; further, that the words "except as aforesaid" after "net," in line 2, be struck out.

Amendments put and passed, and the clause as amended agreed to.

Bill reported with further amendments, and the report adopted.

# CONSTITUTION ACTS AMENDMENT BILL.

#### IN COMMITTEE.

Consideration resumed from 6th December, on proposed new clause relating to newly divided provinces, and on amendment.

Hon. J. W. HACKETT: In default of the required majority being present to pass, this Bill, he suggested that progress be reported. One difficulty about the amendment discussed at the last sitting was that within one month of the coming into operation of the Bill, the sitting member was to elect which province as divided he would represent, and thereon his seat for the original province became vacant. Supposing two of the members who were at present sitting for the North-East province resigned their seats, and within a month after the coming into operation of the Bill they elected to
