Abattoirs Act (9 Ed., No. 27)—

An Act to provide for the establishment of Public Abattoirs, and for other purposes incidental thereto. Introduced by the Minister for Agriculture, 1st September, 1909. Assent given.

Administration Act Amendment Act (9 Ed., No. 25)—

An Act to amend the Administration Act, 1903. Introduced by the Colonial Treasurer, 22nd September, 1909. Assent given.

Agricultural Bank Act Amendment Act (9 Ed., No. 46)—

An Act to further amend the Agricultural Bank Act, 1906. Introduced by the Minister for Lands, 1st September, 1909. Assent given.

Agricultural Lands Purchase Act (9 Ed., No. 42)—

An Act to make better provision for the purchase of lands suitable for immediate settlement, and for facilitating settlement on the land. Introduced by the Minister for Lands, 18th November, 1909. Assent given.

Appropriation Act (9 Ed., No. 54)—

An Act to appropriate and apply out of the Consolidated Revenue Fund and from moneys to credit of the Trust Fund, and the Loan Suspense Account certain sums to make good the supplies granted for the service of the year ending the thirtieth day of June, One thousand nine hundred and ten, and to supplement grants made by the present Parliament during its last session in adjustment of the vote "Advance to Treasurer, 1908-9," for charges during the year ended the 30th day of June, 1909. Introduced by the Colonial Treasurer, 20th December, 1909. Assent given.

Bills of Sale Act Amendment Act (9 Ed., No. 20)—

An Act to amend the Bills of Sale Amendment Act, 1906. Introduced by the Colonial Secretary, 29th July, 1909. Assent given.

Boyup-Kojonup Railway Act (9 Ed., No. 34)—

An Act to authorise the construction of a railway from Boyup to Kojonup. Introduced by the Minister for Works, 10th November, 1909. Assent given.

Coolgardie Recreation Reserve Revestment Act (9 Ed., No. 24)—

An Act to vest Coolgardie Town Lot 1080 in the Municipality of Coolgardie. Introduced by the Minister for Lands, 6th October, 1909. Assent given.

Cottesloe Beach Rates Validation Act (9 Ed., No. 41)—

An Act to Validate the general rates made by the Road Board of the Road District of Cottesloe Beach, formerly Buckland Hill. Introduced by the Minister for Works, 14th December, 1909. Assent given.

District Fire Brigades Act (9 Ed., No. 47)—

An Act to make further provision for the Protection of Life and Property from fire. Introduced by the Premier, 14th September, 1909. Assent given.

Dowerin-Merredin Railway Act (9 Ed., No. 38)—

An Act to authorise the construction of a railway from Dowerin to Merredin. Introduced by the Minister for Works, 10th November, 1909. Assent given.

Employment Brokers Act (9 Ed., No. 53)—

An Act for the regulation of Employment Brokers. Introduced by the Colonial Secretary, 3rd August, 1909. Assent given.

Goomalling-Wongan Hills Railway Act (9 Ed., No. 37)—

An Act to authorise the construction of a Railway from Goomalling to Wongan Hills. Introduced by the Minister for Works, 10th November, 1909. Assent given.

Industrial Conciliation and Arbitration Act Amendment Act (9 Ed., No. 43)—

An Act to amend the Industrial Conciliation and Arbitration Act, 1902. Introduced by the Attorney General, 17th December, 1909. Assent given.

Interpretation Act Amendment Act (9 Ed., No. 51)—

An Act to amend the Interpretation Act, 1898. Introduced by the Attorney General, 8th December, 1909. Assent given.

Land Act Amendment Act (9 Ed., No. 35)—

An Act to further amend the Land Act, 1898. Introduced by the Minister for Lands, 18th November, 1909. Assent given.

Land Tax and Income Act (9 Ed., No. 36)—

An Act to impose a Land Tax and an Income Tax. Introduced by the Colonial Treasurer, 9th November, 1909. Assent given.

Land Act Special Lease Act (9 Ed., No. 29).—

An Act to enable a Special Lease to be granted under "The Land Act, 1898," of portions of B Reserve No. 2020. Introduced by the Minister for Works, 22nd September, 1909. Assent given.

Legal Practitioners' Act Amendment Act (9 Ed., No. 33)—

An Act to amend the Legal Practitioners' Act, 1893. Introduced by Mr. Bath, 1st September, 1909. Assent given.

Legitimation Act (9 Ed., No. 40)—

An Act to amend the law by making provision for the Legitimation of Children born before marriage, by the subsequent marriage of their parents. Introduced by the Colonial Secretary, 30th November, 1909. Assent reserved.

Leonora Tramways Act (9 Ed., No. 44)—

An Act to confirm a Provisional Order authorising the construction of certain Tramways in the Municipal District of Leonora and in the North Coolgardie Road District, and to repeal the Leonora Tramway Act, 1902. Introduced by the Minister for Works, 14th December, 1909. Assent given.

Licensed Surveyors Act (9 Ed., No. 21)—

An Act to provide for the registration and licensing of land surveyors; to control the practice of such surveyors, and for other purposes incidental thereto. Introduced by the Premier, 1st September, 1909. Assent given.

Metropolitan Water Supply, Sewerage, and Drainage Act (9 Ed., No. 39)—

An Act to constitute the Metropolitan Water, Sewerage, and Drainage Area; to establish the method of control, and for other purposes incidental thereto. Introduced by the Minister for Works, 1st September, 1909. Assent given.

North Perth Tramways Act (9 Ed., No. 31)—

An Act to confirm a further provisional order to amend and vary a certain provisional order authorising the construction of tramways in the Municipality of North Perth. Introduced by the Minister for Works, 27th October, 1909. Assent given.

Permanent Reserves Rededication Act, No. 1 (9 Ed., No. 23)—

An Act to change the purpose of certain Permanent Reserves. Introduced by the Premier, 6th October, 1909. Assent given.

Permanent Reserves Rededication Act, No. 2 (9 Ed., No. 52)—

An Act relating to certain Permanent Reserves. Introduced by the Minister for Agriculture, 13th October, 1909. Assent given.

Public Education Endowment Act (9 Ed., No. 28)—

An Act for the Endowment of Public Education. Introduced by the Minister for Education, 7th September, 1909. Assent given.

Redemption of Annuities Act (9 Ed., No. 30)—

An Act for the Redemption of Annuities charged on or issuing out of land. Introduced by the Attorney General, 1st September, 1909. Assent given.

Registration of Deeds Amendment Act (9 Ed., No. 32)—

An Act to amend an Ordinance to consolidate and amend the laws relating to the registration of deeds, wills, judgments, and conveyances affecting real property. Introduced by the Colonial Secretary, 25th November, 1909. Assent given.

Roads Act Amendment Act (9 Ed., No. 48)—

An Act to further amend the Roads Act, 1902. Introduced by the Minister for Works, 14th December, 1909. Assent given.

Sea-carriage of Goods Act (9 Ed., No. 22)—

An Act relating to the sea-carriage of goods. Introduced by the Premier, 29th July, 1909. Assent given.

Settled Land Act Amendment Act (9 Ed., No. 45) —

An Act to amend the Settled Land Act, 1892. Introduced by the Attorney General, 20th October, 1909. Assent given.

Supplementary Loan Act (9 Ed., No. 49) —

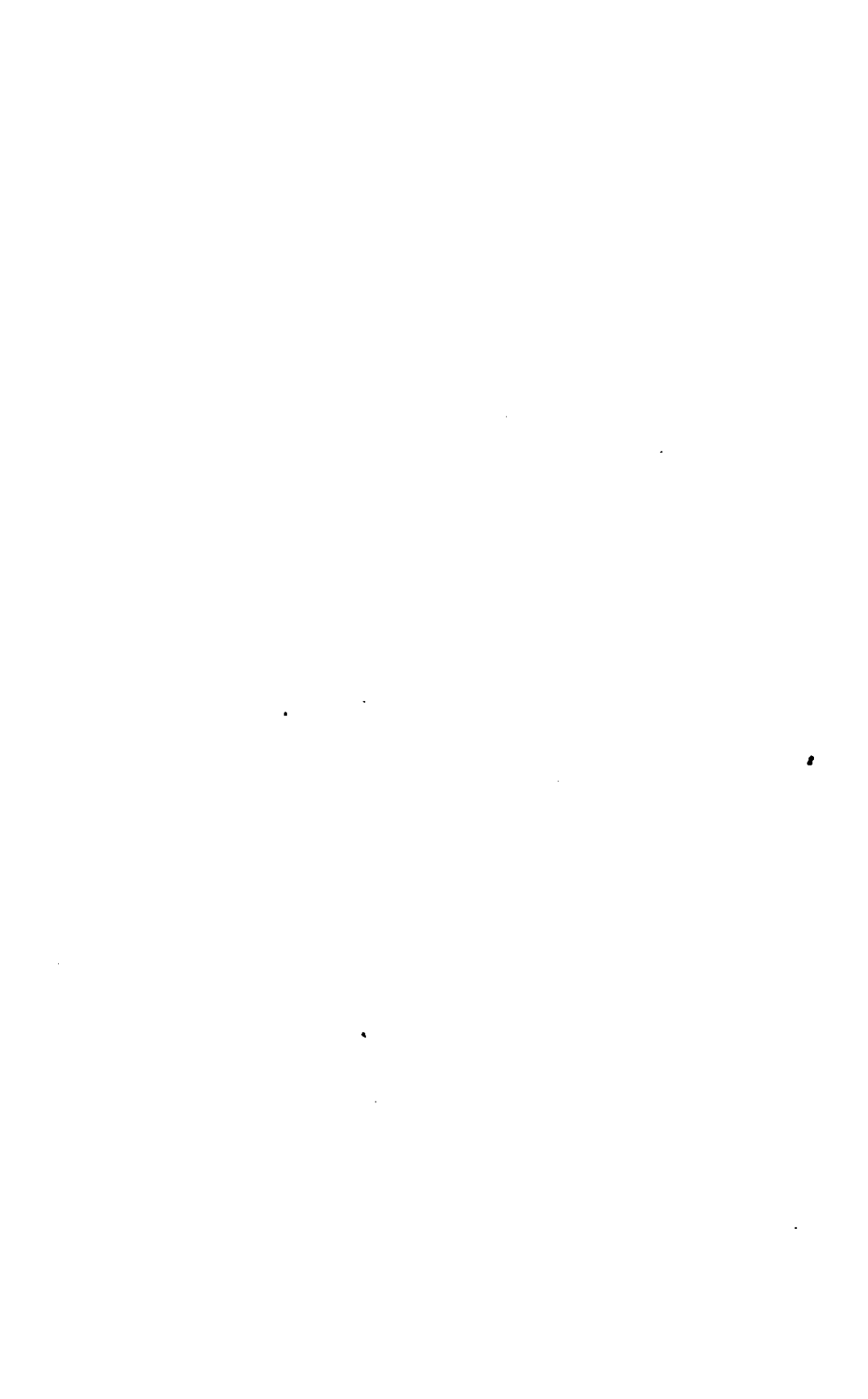
