## QUESTION—DISTRESS IN AGRI-CULTURAL DISTRICTS.

Mr. LANDER (without notice) asked the Premier: Can the Government see their way at once to grant assistance in cases of practical starvation now existing among the farming community? There are instances where the wives and families of farmers are absolutely in a state of destitution, and immediate assistance is required. I may add that on the platform of Merredin railway

station last night I heard pitiful stories of want.

The PREMIER replied: I am sure the hon, member will appreciate the fact that it is not possible for the Government to give a general reply to a question of that kind. All I can say at the moment is that the Government will, of course, have to find ways and means of feeding the people, and that we are endeavouring to do so. If specific cases of destitution are brought under our notice, we will undoubtedly furnish the necessary supplies.
