AUSTRALASIAN FEDERATION ENABLING ACT (63 Vict., No. 55)—

An Act to make provision for the acceptance and enactment of a Federal Constitution for Australasia. [Introduced in Assembly by the Premier, 17th May; Assented to, 13th June.]

SUPPLY ACT, £450,000 (63 Vict., No. 56)—

An Act to apply out of the Consolidated Revenue Fund, and from moneys to credit of the General Loan Fund, the sum of £450,000 to the service of the year ending 30th June, 1901. [Introduced in the Assembly by the Premier, 13th June; Assented to, 14th June.]
