1. Meeting of Council

The Council assembled at 1.00pm pursuant to order.

No. 8

Clause 12, page 11, line 2 — To delete "so." and insert:

so and the restoration must be undertaken by a qualified tradesperson, a copy of whose invoice the tenant must provide to the lessor within 14 days of the restoration being completed.

Hon Michael Mischin moved that the Council does not insist on amendment No. 8 and makes the following alternative amendment —

Page 11, line 2 — To delete "so." and insert:

so and, where restoration work has been undertaken by a tradesperson, must provide to the lessor a copy of that tradesperson's invoice within 14 days of that work having been performed.

Debate ensued.

No. 15

Clause 31, page 30, line 17 — To delete "fundamental".

The Minister for Regional Development representing the Minister for Commerce and Industrial Relations moved —

That the Council does not insist on Amendment No. 15.

No. 21

Clause 35, page 34, line 25 — To delete "tradesperson; and" and insert:

tradesperson, a copy of whose invoice the long-stay tenant must provide to the park operator within 14 days of the alterations being completed; and

Hon Rick Mazza moved —

That the Council insists on its Amendment No. 21.

Debate ensued.

Question — put and passed.

No. 22

Clause 35, page 34, line 32 — To delete "so." and insert:

so and the restoration must be undertaken by a qualified tradesperson, a copy of whose invoice the tenant must provide to the park operator within 14 days of the restoration being completed.

Hon Michael Mischin moved that the Council does not insist on amendment No. 22 and makes the following alternative amendment —

Page 34, line 32 — To delete "so." and insert:

so and, where restoration work has been undertaken by a tradesperson, must provide to the park operator a copy of that tradesperson's invoice within 14 days of that work having been performed.

Debate ensued.

Question — put and passed.

No. 23

Clause 35, page 34, after line 32 — To insert:

(6) The long-stay tenant must give notice of the prescribed alterations to the park operator within 14 days after the alterations have been completed.

The Minister for Regional Development representing the Minister for Commerce and Industrial Relations moved —

That the Council does not insist on Amendment No. 23.

Debate ensued.

Question — put and passed.

The President resumed the Chair.

• that the Council does not insist on but has made an alternative amendment in substitution for its Amendment No. 22 as follows —

so and, where restoration work has been undertaken by a tradesperson, must provide to the park operator a copy of that tradesperson's invoice within 14 days of that work having been performed.

The Leader of the House representing the Attorney General moved, That the Bill be read a second time. The Leader of the House representing the Attorney General tabled an Explanatory Memorandum relating to the Bill. (Tabled Paper 2306).

Debate stands adjourned and Bill discharged and referred to the Standing Committee on Uniform Legislation and Statutes Review [SO 126].

15. Births, Deaths and Marriages Registration Amendment (Change of Name) Bill 2018

The Leader of the House representing the Attorney General moved, That the Bill be read a first time.
