3307. Dr K.D. Hames to the Minister for Health

I refer to the Elective Surgery Wait List Report for February 2008 in which (on page 3) it is noted that the total number of admissions for February was 4,799 and (on page 9) that the number of Ambulatory Surgery Initiative (ASI) cases undertaken was 958. I also refer to the Minister's answer to Question on Notice No. 3140, dated 11 March 2008, in which the Minister advised that the surgery waiting list in 2007 had been significantly reduced, largely by a dramatic rise in Ambulatory Surgery Initiative (ASI) procedures, and I ask:

(a) can the Minister advise if the number of 'admissions' in the monthly report include ASI figures?

3308. Dr S.C. Thomas to the Treasurer

I refer to Question Without Notice No. 103, asked on 20 March 2008, referring to the Treasurer's October 2006 delegation to Europe and the nearly \$100,000 this trip cost, and I ask:

- (a) what hotels or other accommodation did the delegation stay in, and on which dates; and
- (b) what is the breakdown of the expenses of the trip into:
 - (i) flights;

- (ii) accommodation (rooms only); and
- (iii) other expenses?

- (5) Who conducts the four-wheel drive vehicle training courses?
- (6) Where is the training held?
- (7) What specific activities are carried out during the training course?

In relation to the 40 passenger four-wheel drive vehicles in the Government fleet that were written off during the period from 15 March 2006 to 15 February 2008, to which Government department were they allocated?

With reference to passenger four-wheel drive vehicles only within the Government fleet:

- (a) how many vehicles have been involved in serious crashes that have involved injury or death for each year between 2001 and 2007 inclusive;
- (b) what was the location, including the road name, of each of these crashes; and
- (c) of those crashes outlined in (a), how many have resulted in either workers' compensation or insurance claims made against the Government or its insurers?

With reference to passenger four-wheel drive vehicles within the Government fleet:

- (a) how many, if any, people have been injured or killed in each year between 2001 and 2007 inclusive; and

I refer the Minister to the planned traffic lights for the intersection of the South Western Highway / Abernethy Road / Beenyup Road, and ask:

- (a) is it true that three different dates have previously been set for the completion of these lights and that all three dates have passed; and
 - (i) if no to (a), what was the original date for completion;
 - (ii) if yes to (a), what are the reasons for the delay; and
- (b) by what date will these traffic lights be completed and what is the Minister's department waiting on until they complete these works?

3316. Mr A.J. Simpson to the Minister for Planning and Infrastructure

I refer to the Minister's recent statements concerning the extension of the Tonkin Highway and the completion of the Perth to Bunbury Highway and ask:

- (a) does the Minister stand by his previous statement that the residents of Byford will have to wait for the Tonkin Highway extension to reduce the traffic through Byford before major modifications can be carried out on the South Western Highway, such as lane and speed limit reductions; and
- (b) if, as the Minister recently claimed, the Perth to Bunbury Highway is going to make a big difference to the traffic flow through Byford, will the South Western Highway modifications begin when the Perth to Bunbury Highway is completed?

3317. Mr A.J. Simpson to the Minister for Planning and Infrastructure

I refer to the Minister's statement on the upgrading of Orton Road made in the *Comment News* in March, and ask:

- (a) how is upgrading Orton Road expected to improve Byford's traffic problems; and
- (b) can the Minister explain how \$55 million spent on upgrading this road as a temporary solution is of greater value for money than extending the Tonkin Highway, which can allow traffic to entirely bypass Byford?

In regard to Question on Notice No. 3066, can the Minister advise for what period or periods the variable message sign on the Burswood Footbridge across the Great Eastern Highway has displayed an advertisement for westernaustralia.com since it was established in 2006?

With reference to Kalamunda Police Station:

- (a) is any consideration being given to closure or amalgamation with another station;
- (b) if yes to (a), why and what are the details;

- (c) if no to (a), will the Minister guarantee that the station will remain open for at least the next five years; and
- (d) when will a new police station in Kalamunda be constructed?

With regards to the petition presented to the Lower House on 28 February 2008 requesting the Public Transport Authority restructure the school bus services between Donnybrook and Bunbury to include one direct bus service from Donnybrook and Ocean Forrest Lutheran College, I ask:

 - (i) if not, why not; and
- (b) is it going to occur; and if so when; and
 - (i) if not, why not?
