Speakers Statement - Proposed Division of Bill

The Speaker advised members that it was open to the House when commencing consideration in detail to decide that a Bill should be divided into two or more Bills, or indeed to consolidate two or more bills into one. Members should be aware that this was an administrative and procedural motion and could not be used to effect substantive amendments. The only permissible changes were those necessary to enable the division of the Bill into such parts as were considered appropriate by the House and this included any technical or clerical adjustments required to be made by the Clerk.

Once divided, the divided Bills would be listed as separate Orders of the Day.
