## 1324. Hon Alison Xamon to the Leader of the House representing the Attorney General:

I refer to concerns raised by my constituents about potential conflicts of interests in the operations of the Gender Reassignment Board (GRB), and I ask:

- (a) do members of the GRB refer applicants for a Gender Recognition Certificate to their own clinical practices for assessment;

It is noted in a report by Dr Ryan Vogwill on this proposal, the "Scale and Impact of the Gogo Station Irrigated Agriculture Proposal", that the capacity of these dams is more water than can be stored in the Stirling Dam, and close to the amount of water that can be stored in the Wungong Dam in Western Australia's southwest. It is also noted that the water storage in the proposed Gogo dam would be over three times the total surface water allocation of 14.6Gl for the Daly River in the Northern Territory. It is also noted that the Oxford Dictionary defines a dam as, "A barrier constructed to hold back water and raise its level, forming a reservoir used to generate electricity or as a water supply." The proposed Gogo dams would be constructed to hold back floodwaters from the Margaret River that would otherwise flow directly into the Fitzroy River, for the purposes of creating a reservoir for use as a water supply. I ask:

- (k) if no to (j), why not; and
