1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

2. Death of Mr Bob Bloffwitch – a former Member of the Legislative Assembly

The Deputy Premier, on behalf of the Premier, without notice, moved,

That the House records its sincere regret of the death of Mr Bob Bloffwitch and tenders its deep sympathy to his family.

The motion was supported by Mr T.R. Buswell, Mr T.K. Waldron, Mr C.J. Barnett, Mr S.R. Hill, Dr K.D. Hames, Mr M. McGowan, Mr R.C. Kucera, Mr D.F. Barron-Sullivan and Mr F. Riebeling.

Question put and passed unanimously with members and officers of the Assembly standing in their places as a mark of respect.

3. Speaker's Statement – Acting Speakers

The Speaker advised members that the Member for Capel has been released from his duties as Acting Speaker and the Member for Carine had been reappointed in his place.

4. Petitions

Peat Dump and Soil Blending Facility, Nowergup – Mr J.R. Quigley presented a petition from 248 persons requesting that the Minister for the Environment, pursuant to section 38(4) of the *Environmental Protection Act 1986*, make reference of the proposal by Soiland Pty Ltd to establish a large peat dump and soil blending facility in Nowergup to the Environmental Protection Authority for a full environmental impact assessment (P. 280).

Peat Dump and Soil Blending Facility, Gnangara - Mrs D.J. Guise presented a petition from 49 persons requesting that the Minister for the Environment, pursuant to section 38(4) of the Environmental Protection Act 1986, refer the proposal by Soiland Pty Ltd to establish a large peat dump and soil blending facility in Gnangara to the Environmental Protection Authority for a full environmental impact assessment (P. 281).

Municipal Tax (Rates) - Mrs J. Hughes presented a petition from 16 persons requesting that the Legislative Assembly repeal section 6.35 of the Local Government Act 1995 to ensure only proportional Municipal Tax rates would apply to small units and small homes (P. 282).

Ocean Forrest Lutheran College Bus Service – Dr S.C. Thomas presented a petition from 273 persons requesting that the Legislative Assembly request the Public Transport Authority to restructure the school bus service between Donnybrook and Bunbury to include one direct bus service to and from Donnybrook and Ocean Forrest Lutheran College commencing second term in 2008 (P. 283).

Coodanup Community College - Mr D.A. Templeman presented a petition from 613 persons requesting that the Legislative Assembly recommend and support the change of Coodanup Community College from a Middle School to a Senior High School (P. 284).
