**1. Meeting of Council**

The Council assembled at 2.00pm pursuant to order.

The President, Hon Barry House, took the Chair and read prayers.

Hon Stephen Dawson presented a petition from 19 petitioners requesting that the Legislative Council amend the *Mental Health Bill 2013* to promote better protection for involuntary patients. (Tabled Paper 1636).

Hon Darren West presented a petition from 160 petitioners requesting the Legislative Council to investigate the report of the inquiry conducted by the Chief Medical Officer into the death of Mrs Janice Saulys. (Tabled Paper 1637).

**3. Ministerial Statement — Enhancing Family and Domestic Violence Laws — Final Report June 2014**

The Minister for Mental Health representing the Treasurer tabled an Explanatory Memorandum relating to the Bill. (Tabled Paper 1641).
