TUESDAY, 21 AUGUST 2018

1. Meeting of Council

The Council assembled at 2.00pm pursuant to order.

The President, Hon Kate Doust, took the Chair.

Prayers and an Acknowledgement of Country were read.

2. President's Ruling — Standing Order 40 — Personal Explanation

The President ruled as follows —

Last Wednesday during Members' Statements, the Leader of the Opposition raised a point of order regarding the use of Standing Order 40 by the Minister for Regional Development to make a personal explanation. The Leader of the Opposition suggested that the Minister should have used the ministerial statement procedure under Standing Order 103 to make her contribution.

The Minister used the personal explanation procedure under Standing Order 40 to respond to a claim made by Hon Martin Aldridge earlier in the day that she had not complied with her notification obligations under section 82 of the *Financial Management Act 2006* regarding her response to questions asked of her by Hon Martin Aldridge during the 2017–18 budget estimates hearings. Standing order 40 states —

Personal Explanation

- (1) When there is no business before the Council, a Member may, by leave, explain a matter of a personal nature.
- (2) A personal explanation shall not be debated.

When the House grants leave, a personal explanation may be used by any Member, including a Minister, to respond to some misrepresentation of a Member in an earlier debate in the Council or in some other forum or publication. It is not necessary for a Member to claim that they have been misrepresented to use this procedure, but the matter must relate to matters personally affecting the Member. I have examined the *Hansard* from last Wednesday and previous *Hansards* when the procedure has been used. I am satisfied that the Minister's personal explanation comes within the scope of the Standing Order. It is a response to claims made by Hon Martin Aldridge in an earlier debate that relate to Hon Alannah MacTiernan personally in her capacity as a Minister. The Minister sought to explain why the Member's earlier statement misrepresents the situation as it relates to her. I therefore rule that there is no point of order.

Members have a variety of procedures under the Standing Orders to respond to other Members. A Minister may use a Ministerial Statement when matters relate to their ministerial responsibilities, which is Standing Order 103. Members who have spoken to a question may speak a second time during the same debate without leave to explain some part of their speech that has been misquoted or misunderstood by another Member, which is Standing Order 38. A Minister may correct answers to questions after question time and Members may also use Members' Statements to respond. The Standing Orders are interpreted so as to facilitate the

business of the House and it may be the case that more than one procedure is available to a Member to achieve the same or a similar outcome.

3. Petition

Hon Pierre Yang presented a petition from 1,448 petitioners requesting the Legislative Council to support measures for palliative care options to be given to patients at Joondalup, Midland, Peel, Fremantle and Bentley Hospitals. (Tabled Paper 1635).

 - (c) all allegations, including those of intimidation, abuse and racial discrimination, set out in the documentation tabled in the Legislative Council on 26 June 2018 (Tabled Paper 1489) and other allegations dating back to 2012;
 - (d) actions of all parties relevant to mining operations, including but not limited to mine operators, pastoral leaseholders, government agencies and their employees and agents;
 - (e) responses by Ministers and government agencies to complaints;
 - (f) the actions of any other persons or bodies associated with mining operations;
 - (g) reasons why the Department of Mines Industry Regulation and Safety formerly the Department of Mines and Petroleum and successive Ministers have not approved the incorporation of the Common Reserve 10041 into the Pinjin Station Pastoral Lease; and
 - (h) any other related matter.
- (3) The Select Committee is to report no later than six months after the Committee has been established.
- (4) The Select Committee shall consist of five members; Hon Robin Scott (Chair), Hon Robin Chapple, Hon Jacqui Boydell, Hon Kyle McGinn and Hon Michael Mischin (Deputy Chair).
