I refer to Perth Racing's 2013 Belmont Park Winter schedule, and ask:

- (a) to date, how many race meetings have been cancelled or rescheduled and of these cancelled or rescheduled race meetings, what was the primary reason for the cancellation:
- (b) what are the estimated financial losses incurred due to the cancelled race meetings; and
- (c) given that Belmont Park is promoted through Perth Racing's website as one of the best wet weather tracks in Australia, if not the world, thanks to its excellent drainage which has ensured race meetings are consistently held, rain, hail or shine, can you advise what measures have been put in place by track management at Belmont Park to avoid any further cancellations or rescheduling of race meetings?
