- (c) has the creation of the committee produced the additional 1,600 jobs as outlined in the LandCorp Annual Report, and if not why not; and
- (d) how many additional jobs have been created?

1060. Mr M. McGowan to the Minister for Environment:

I refer to the State Reception Centre, and ask:

- (a) how many private functions were held at the Centre between 1 January 2013 and 1 June 2013;
- (b) what is the name of the company, group or organisation which held private functions at the Centre between the above mentioned dates;
- (c) what was exact date of the function held for each company, group or organisation outlined in (b);
- (d) what were the venue hire fees charged for each company, group or organisation outlined in (b); and
- (e) on what specific dates, if any, were State Government functions held at the Centre between 1 January 2013 and 1 June 2013?
