1. Meeting of Council

The Council assembled at 1.00pm pursuant to Temporary Orders. The President, Hon Barry House, took the Chair and read prayers.

2. Petition

Hon Mark Lewis presented a petition from 72 petitioners requesting the Legislative Council to support the Government resourcing a food security capacity building project in Broome for Aboriginal children in need. (Tabled Paper 2649).

3. Review of the RSPCA — Amendment to Notice of Motion

Hon Rick Mazza, pursuant to Standing Order 62(a), amended Motion No. 3 — *Review of the RSPCA*, to read as follows —

- (1) That the Council establishes a Select Committee to inquire into the operations of the Western Australian Royal Society for the Prevention of Cruelty to Animals (the '**RSPCA**'), including an examination of
 - (a) its funding from the Government;
 - (b) its objectives; and
 - (c) the use of its powers.
- (2) The membership of the Select Committee is to be five Members, and is to include the Member from the Shooters and Fishers Party.
- (3) The Member from the Shooters and Fishers Party shall be the Chair.
- (4) The Select Committee is to report to the Council by no later than Thursday, 3 December 2015.

4. Waterways — Environmental Degradation

Motion No. 1 having been called, debate resumed on the motion of Hon Sally Talbot, as follows ----

That this Council condemns the Barnett Government for its failure to take effective action to protect Western Australia's rivers, estuaries and inlets from environmental degradation.

To delete "condemns the Barnett Government for its failure to take effective" and insert —

acknowledges the actions taken by the Barnett Government and supports further ongoing
