1. Meeting of Council

The Council assembled at 4.00pm pursuant to order.

The President, Hon John Cowdell, took the Chair and read prayers.

2. Petitions

Hon Giz Watson presented a petition from 1 037 residents of Western Australia requesting an investigation into 35 000 tonnes of radioactive ore remaining uncovered at Yellirrie and to rehabilitate and make the contaminated area safe. (Table paper 429).

Hon Giz Watson presented a petition from 1 631 residents of Western Australia opposing the proposal to establish a uranium mining industry in Western Australia. (Table paper 430).

- (a) the Corporations (Western Australia) Act 1990;
- (b) the Australian Securities and Investments Commission Act 1989;
- (c) the Corporations Act 1989;
- (d) an Act amending an Act referred to in paragraph (b) or (c);
- (e) the new ASIC Act; or
- (f) the new Corporations Act.

Debate ensued.
