MOTIONS

34. Management of the Health System in Western Australia (*Notice given November 21 2003*)

Resumption of debate (Wednesday, March 10 2004) on the amendment of the Parliamentary Secretary to the Minister for Health as follows -

To delete all words after "That this House notes" and insert instead -

“

- (1) The development of a long term vision for the delivery of health care in Western Australia through the Reid Review;
- (2) The extent of the public and stakeholder consultation leading to the Reid Review Plan which will provide the framework for health care delivery into the future;
- (3) The commitment of an additional \$10 million to offer surgery to all 3 200 on the "long wait" list for more than 500 days;
- (4) The commitment of an additional \$2 million to offer dental treatment to 3000 Western Australians who had waited the longest for dental treatment;
- (5) That these initiatives, while important, will still leave an unacceptable waiting list and waiting time for surgical and dental procedures and the need for further initiatives to address this problem;
- (6) The need for a comprehensive resourced strategy to ensure patient access to Emergency Departments and if need be admission to hospital;

- (7) The difficulties which have arisen as a result of -
- (a) inadequate federal funding for health in WA through the Australian Health Care Agreement; and
 - (b) the Howard Government's withdrawal of funding for the Commonwealth Dental Scheme in 1996.

Accordingly, the House notes the significant efforts made by the Government to control health expenditure and redirect resources to the areas of greatest need and urges the Government to take even further steps to achieve better health outcomes for the Western Australian population.

- (1) The poor performance of the Gallop Labor Government in its management of the health system in Western Australia.
- (2) The inability of the Government to manage the finances of the health portfolio, which has led to adverse and unjustifiable cuts to a wide number and variety of health services around the State.
- (3) The consequent funding cuts to many areas of Government activity other than health services which have occurred as a result of the rapid and uncontrolled escalation of the health budget in recent years.

Hon Norman Moore: To move -

- (1) A select committee of 3 members is established.
- (2) Chapter XXII of standing orders apply to the committee as if it were a committee established under that Chapter.
- (3) The committee is to inquire into and report not later than June 30 2004 on -
 - (a) the adequacy or otherwise of the State Planning Commission's review of the proposed Fremantle Eastern Bypass and the basis for recommending the deletion of the proposal as contained in MRS Amendment 1055/33;
 - (b) any matter with respect to paragraph (a) that the committee believes should be drawn to the attention of the House.

37. Independent Schools and Government Funding Levels (*Notice given December 10 2003*)

Hon Alan Cadby: To move -

That this House condemns the Minister for Education and Training for his continual attacks on independent schools and the rights of parents to choose the most appropriate school for their children.

It also notes the misinformation propagated by the Minister on aspects of the Government funding levels of schools.

38. Rural Western Australian Funding (*Notice given December 11 2003*)

Hon Bruce Donaldson: To move -

That this House notes with great concern -

- (1) The reduction of funding for Infrastructure and Services in Rural and Regional Western Australia by the Gallop Government.
- (2) Programs being developed which involve cost-shifting from Government to Local Government.
- (3) Lack of commitment to develop a Decentralisation Policy for Rural Western Australia, providing an opportunity for economic diversification in communities.

- (3) Require the Secretary of the Legal Practice Board to provide such information and documentation that will assist the Committee in its enquiries and to declare whether the Board received any request from the current Attorney General to provide information to assist in the preparation of an answer to either parliamentary question and if so, details of what the request and reply were.

This Legislative Council condemns the Gallop Government in the strongest terms for its neglect of Hospital facilities, services, and patient care in the South-West areas of Western Australia, with particular regard to -

- (1) Its failure to support smaller town hospitals.
- (2) Its centralising control and services into the Metropolitan area.
- (3) Its centralising of purchasing away from smaller country towns.
- (4) Its abolition of local hospital boards and the subsequent loss of "community ownership" which generates pride and voluntary support.
- (5) The continual erosion of resources at the service delivery point leading to low staff morale and decline in appropriate care to these communities.

45. Electricity Supply in Non Metropolitan Areas (*Notice given December 12 2003*)

Hon Bill Stretch: To move -

That this House records its alarm at the deteriorating state of Western Australia's electricity supply and distribution network in non-metropolitan areas and calls on the Government to allocate sufficient funds urgently to Western Power or other contractors to commence upgrading the line network immediately, with particular emphasis on -

- (1) Enlarging and extending high-voltage main lines.
- (2) Accelerating the pole replacement programme.
- (3) Upgrading the feeder lines and supply lines to customers.

And the House notes that such work is required to begin at once, whatever the outcome of current legislative changes, to maintain the viability and sale value of the distribution network.

46. Protecting Western Australian Property from Bushfire and Wildlife (*Notice given December 12 2003*)

Hon Bill Stretch: To move -

That this House condemns the Gallop Government for its lack of resolve to protect Western Australian property from bushfire and wildlife as demonstrated by -

- (1) Its failure to ensure that sufficiently large areas of protective burning are carried out.
- (2) Its failure to allow necessary protective burning to be carried out for fear of perceived and exaggerated smoke hazard in urban areas.
- (3) Its failure to permit adequate protective burning in National Parks and so-called Old Growth forest areas thus endangering the lives of tourists, firefighters and local residents, as well as the aforesaid vegetation itself.
- (4) Its failure to allocate sufficient funding to allow the aforementioned protective burning to take place.

 - Any other matters that impact on the good growth and development of young children; and
 - The impacts of Government and industry policy on the wellbeing of children.
- (3) The Committee has power to send for persons, papers and records and to travel from place to place.
- (4) The Committee report to the House not later than June 30 2004 and if the House do then stand adjourned, the Committee to deliver its report to the President who shall cause the same to be printed by authority of this order.

 - (B) “the Organisation was insolvent”; and
 - (C) “W.A.A.C.C.H.O.’s solvency is being maintained currently by Grant Funding of its operations, provided by the O.A.H.”; and
 - (iii) authorising payment of funds to W.A.A.C.C.H.O. in 2002-2003 after the Organisation had developed a three year Business Plan, cleared debts and implemented financial management reforms; and
 - (b) the role and conduct of the Minister for Health in withdrawing funding in August 2003 from W.A.A.C.C.H.O. and from the Joint Planning Forum in September 2003 -
 - (i) having regard to the solvency and performance of W.A.A.C.C.H.O. in relation to any contract documents with O.A.H.; and
 - (ii) having regard to obligations of the Government under the Health Framework Agreement signed in July 2002 with the Commonwealth Government, the Aboriginal and Torres Strait Islander Commission and W.A.A.C.C.H.O.;
