THURSDAY, 18 FEBRUARY 2016

1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Barry House, took the Chair and read prayers.

2. Joint Standing Committee on Delegated Legislation — Report No. 83 — Annual Report 2015

Hon Robin Chapple presented Report No. 83 of the Joint Standing Committee on Delegated Legislation, *Annual Report 2015*. (Tabled Paper 3839).

3. Environmental Protection

Non-Government Business No. 1 having been called, Hon Lynn MacLaren moved, without notice —

That this Council notes environmental protection is in crisis in this State. There have been repeated and significant incidents that demonstrate that the Government is failing to protect our environment.

The Council draws attention to the —

- (a) felling of ancient and significant trees including the 500 year old Jarrah tree in the Roe 8 reserve;
- (b) Supreme Court's decisions to invalidate two environmental approvals James Price Point and Roe 8;
- (c) recent listing of three Western Australian species (woylie, western ringtail possum and Gilbert's potoroo) on the Commonwealth's rare and threatened species list; and
- (d) ongoing uncertainty about the role and integrity of the Environmental Protection Authority.

Noting these environmental protection failings, this Council asks the Barnett Government to initiate an urgent inquiry into the protection of Western Australia's biodiversity and the implementation of the *Environmental Protection Act 1986*.

Debate ensued.

4. Bushfire Management

Private Members' Business No. 1 having been called, Hon Nigel Hallett moved, without notice — That the Council —

(a) recognise that a new arrangement for bushfire management is urgently required in Western Australia including the need to promote a new culture in our bushfire authorities moving from emergency response and an 'all-out suppression approach' to one of fire prevention and damage mitigation;

- (b) recognise that large bushfires result from failed land management; and
- (c) identify the urgent need for the Western Australian Government to create a separate 'country fire service' to manage emergencies directed by a Board made up of Parks and Wildlife, Association of Volunteer Fire Fighters and the Western Australian Local Government Association.

Debate ensued. *Motion lapsed.*
