# MINUTES OF PROCEEDINGS

## TUESDAY, 16 JUNE 2015

## 1. Meeting of Council

The Council assembled at 2.00pm pursuant to Temporary Orders. The President, Hon Barry House, took the Chair and read prayers.

### 2. Statement by President — Magna Carta

The President made the following Statement —

On 15 June 2015, that is, yesterday, celebrations were held around the English-speaking world to commemorate the 800th anniversary of King John's signing of the *Magna Carta* at Runneymede, England, in 1215. In reality, the original *Magna Carta* was not signed by King John, but sealed with the King's seal and those of the great barons on that date.

For some scholars, the Latin for *Magna Carta* translates into "Great Charter" in recognition of the document's cultural, political and legal significance. For other scholars, *Magna Carta* simply means "Big Charter", given that King John issued two charters in 1215, one on a large piece of vellum, and the other on a small piece of vellum.

King John must have thought that the original version of the *Magna Carta* was significant, because he immediately petitioned the Pope to declare it void. Among other things, King John objected to the charter because his agreement to it was given while his barons had him under extreme duress. At the time, England was under a papal interdict placing everyone's souls in jeopardy and King John also needed to raise taxes in order to pay off his latest round of war debts. The Pope obliged King John less than two months later by declaring the *Magna Carta* a nullity and lifting the papal interdict.

Between 1215 and 1297, the *Magna Carta* was reissued four times, but without its enforcement clause, and was confirmed on about 55 occasions by different sovereigns until 1416. Some sovereigns chose to ignore it, but it has endured. Some of the clauses of the *Magna Carta* were later adopted into the statute books of most of the former colonies of the United Kingdom, including the constitutions of several American states. It has even been adopted expressly into the statute books by a number of Australian jurisdictions in their Imperial Acts Application Act. In Western Australia, the *Magna Carta* was part of the received law of Great Britain when the colony was established in 1829. A well-known clause in the *Magna Carta* considered by many as the progenitor of our present day liberties can be found in chapter 29, and reads —

No freeman shall be taken or imprisoned, or be disseised of his freehold, or liberties, or free customs, or be outlawed, or exiled ...but by lawful judgment of his peers, or by the law of the land.

...we will sell to no man, we will not deny or defer to any man either justice or right.

This chapter is the origin of the writ of *habeas corpus*. It demonstrates an early commitment to the rule of law by a reluctant absolute monarch whose personal creed was "by force and by will".

For many, the *Magna Carta* is the forerunner of our modern liberal Westminster democracy. Its sentiments can be traced through such documents as English *Bill of Rights 1689*; the American Declaration of Independence; the *Bill of Rights 1791* of the United States of America; the *Universal Declaration of Human Rights 1948*; the European Convention on Human Rights 1951; and the United Kingdom's *Human Rights Act 1998*. Notably, Eleanor Roosevelt, wife of President Franklin D. Roosevelt, who chaired the drafting committee of the 1948 *Universal Declaration of Human Rights*, called it the "*Magna Carta* for all mankind", the concept being the expansion of the *Magna Carta* from a defined and then relatively small group of freemen within a kingdom to universal applicability.

For others, the *Magna Carta* is just an important moment in the journey of western civilisation. There has clearly been a long history of reverence for the *Magna Carta* and the king's promise of access to justice. For most the significance of the *Magna Carta* is that it represents the idea of law by consent of those being governed and the civilising possibility of equality of justice as an answer to force and arbitrary rule by so-called divine right. These ideas were as noble in 1215 as they were during the Constitution debates and subsequent colonial referendums that gave birth to our federal system of government. Indeed, these ideas remain both noble and relevant in the twenty-first century.

In concluding, I advise Members that next week a display, which has been prepared by the State Records Office in honour of the 800th anniversary of the *Magna Carta*, will be installed in the Parliament House foyer. The display explores the development of representative democracy in Western Australia through historic state archives.
