Hon Liz Behjat moved, without notice —

9. Aboriginal Communities — Closure

Non-Government Business No. 1 having been called, Hon Ken Travers moved, without notice —

That this House expresses concern at the Barnett Government's intention to close a number of remote Aboriginal communities, and calls on the Government to —

- (a) consult directly with the communities on their future; and
- (b) recognise that the size and geographic location of communities throughout regional Western Australia should not be the sole determinant of whether they receive State support.

Debate ensued.

Motion lapsed.

10. Personal Explanation

Hon Ken Travers sought leave to make a personal explanation as he believed he had been misunderstood by the previous Member [SO 38].

Point of Order

Hon Nick Goiran raised the following Point of Order —

With respect to the decision to allow Hon Ken Travers a second opportunity to speak, I draw your attention, Mr President, to the time limits that are provided for these motions. It is my submission to you, Mr President, that Standing Order 38 must be considered in the context of the other Standing Orders, including the time limits. It is my respectful submission to you, Mr President, that the intention behind this Standing Order is to allow a Member a second opportunity to speak during the time that is allocated for that particular motion or that particular item of business. For example, as we know, had there been sufficient time in the ordinary course of events, Hon Ken Travers would not have had another opportunity to speak, other than having a right of reply because of the fact that he was the mover of the motion. Other Members, including the many others who contributed, would not have had a second

opportunity to speak but had there been sufficient time, they might have appealed to you, Mr President, under Standing Order 38.

My brief submission to you, Mr President, is that Standing Order 38 must be considered in light of the time limits that apply for items of business. I respectfully suggest that it cannot be the case that Members can, after the time allowed, have another opportunity to speak because, frankly, every other Member who spoke during that time-limited debate this morning could also appeal to you under Standing Order 38 and seek another opportunity to speak. I would suggest that that is not what was intended when Standing Order 38 was created.

President's Ruling

The President ruled as follows —

I have considered the matter. As I said before, I am prepared to allow the Member to make a statement. I would rather it be made under Standing Order 40 than Standing Order 38. That would then overcome the technical point raised by Hon Nick Goiran in his point of order. Nevertheless, it is a very narrow opportunity for a Member to either clarify or correct something that was said during a debate.

Leave granted.

11. International Men's Day

Private Members' Business No. 1 having been called, Hon Nick Goiran moved, without notice — That this House —

- (a) acknowledges that Wednesday, 19 November 2014 was International Men's Day and thanks the men of Western Australia for their contribution to this State:
- (b) recognises that in order for our interdependent society to be a truly great one, it requires, amongst other things, male role models who are both positive and effective; and
- (c) implores all residents of Western Australia to encourage men and boys, irrespective of opportunities, finances or personal circumstances, to make life decisions based on the principles of integrity, dignity and respect.

Debate ensued. *Motion lapsed.*

- (4A) The prison officer must be advised of
 - (a) the implications of giving information, answering any question or producing a document when required to do so under subsection (4); and
 - (b) the relevance of the information or document that is required for the purpose of the investigation.

Hon Lynn MacLaren, by leave, tabled a letter from the Law Society of Western Australia being its submission to the Standing Committee on Legislation's inquiry into the Bill. (Tabled Paper 2281). Debate resumed.

Page 8, lines 19 and 20 — To delete "or 12 months' imprisonment, or both."

Page 8, line 21 — To delete "Notice of loss of confidence" and insert —

Written notice of CEO's determination

Debate ensued.

Amendment — put and negatived.

Debate resumed.

Hon Sally Talbot moved —

Page 10, lines 7 to 10 — To delete the lines and insert —

(2) The Minister shall appoint an independent third party to review each maintenance period, and in the event that the independent third party determines that exceptional circumstances apply, the Minister shall direct that a maintenance payment must continue to be paid to the prison officer for a specified period after the maintenance period.

Debate ensued.

Amendment — put and negatived.

Hon Kate Doust moved —

Page 10, after line 14 — To insert —

- (3A) At the end of the specified period, the Minister shall review the progress of the appeal and renew the maintenance period for a further specified period not exceeding 6 months unless
 - (a) the appeal has been determined by the WAIRC; or
 - (b) there are exceptional circumstances justifying why the prison officer should not be paid a maintenance payment.
