1. Meeting of Assembly

The Assembly met at 9.00 a.m. pursuant to adjournment.

3. Joint Standing Committee on the Corruption and Crime Commission

The Speaker advised members that he had received a letter dated 14 August 2013 from the Chairman of the Joint Standing Committee on the Corruption and Crime Commission, advising that the Committee had resolved to conduct an inquiry with the following terms of reference:

The Committee will inquire into and report on:

- (a) the role played by the Corruption and Crime Commission within the State's Integrity Coordinating Group (ICG);
- (b) the extent of any jurisdictional overlap between the CCC and other members of the ICG;
- (c) how the CCC handles instances of jurisdictional overlap with other members of the ICG;
- (d) the costs and benefits of the CCC's participation in the ICG;
- (e) any operational implications of the CCC's participation in the ICG; and
- (f) the model used by other misconduct and anti-corruption agencies in establishing their relationships with agencies within their jurisdiction.

The Committee proposes to report to the House by 30 April 2014.
