The Joint Standing Committee on Audit has appointed Vista Advisory Pty Ltd to undertake a review of the operation and effectiveness of the *Auditor General Act 2006*. The Vista Advisory review will be a performance review of the Office of the Auditor General. A review of the Act will be conducted at a later stage and will be informed by the outcomes of the performance review.

As part of the performance review program, Vista Advisory staff will be attending Parliament House tomorrow and on Thursday, 13 August 2015 in room 1.29 from 10.00 am to 6.00 pm. Vista Advisory will be available to Members of both Houses on both days to allow them to provide individual input into the review process. As key stakeholders in the services provided by the Office of the Auditor General, I urge all Members to take advantage of this unique opportunity to become involved in the review process. Members' comments will inform the review and may result in the more effective operation of this important statutory office.
