- (4) When varying or fixing a day and time of meeting not less than 4 days' notice shall be given to each Member.
- (5) For the purposes of (3)(b):
 - (a) A request by the leader or deputy leader of a party in the Council shall be deemed to be a request by every member of that party who is a member of the Council.
 - (b) A request may be made to the President by delivery to the Clerk, who shall immediately notify the President.
 - (c) If the President is unavailable, the Clerk shall notify the Deputy President, or, should the Deputy President be unavailable, any one of the Deputy Chairs of Committees, who shall be required to summon the Council on behalf of the President, in accordance with this temporary order.
- B. That the proposed amendment is referred to the Standing Committee on Procedure and Privileges for consideration and report within three months.

Leader of the House moved, without notice —

To amend Motion No. 1 – Standing Order 6(3) — Referral to the Standing Committee on Procedure and Privileges as follows —

C. That each party leader not a member of the Standing Committee on Procedure and Privileges be co-opted to the committee for the purpose of this referral.

Debate ensued.

Point of Order

Hon Simon O'Brien raised the following Point of Order —

The point of order is that it is a convention of this House that the President not be involved personally or that no Member seeks to involve personally the President of the House in the debate before the Chair. I think the Member should perhaps find another line of argument.

President's Ruling

The President ruled as follows —

You are correct, Hon Simon O'Brien. I think that Hon Martin Aldridge might have received that message and he will not be going back over that ground again today.

Debate resumed.

Point of Order

Hon Simon O'Brien raised the following Point of Order —

The point of order that I raised just now is a valid one and the discipline and dignity of the House relies on such precedents. Although my friend is pursuing this matter with vigour, and that is fine, the fact of the matter is that I think the ruling that was very genteelly made was that my point of order was upheld. Therefore, the honourable Member is out of order in then persisting with his remark that he had "made the point". That is not the way that we conduct ourselves in this House, and I would ask that he withdraw that remark.

President's Ruling

The President ruled as follows —

You are right, we do have to maintain, as you already referenced, some of those conventions. It is appropriate. So, Member, I ask you to withdraw those comments you made previously about the election of the President in this Chamber and then you can continue on with your other remarks about this amendment.

Hon Martin Aldridge withdrew his remark.

Debate resumed.

Amendment — put and passed.

Debate resumed.

Motion, as amended, agreed to.

4. Select Committee into alternate approaches to reducing illicit drug use and its effects on the community

Motion No. 2 having been called, Hon Alison Xamon, pursuant to notice, moved —

- (1) A Select Committee examining alternate approaches to reducing illicit drug use and its effects on the community is established.
- (2) The Select Committee is to inquire into and report on
 - (a) other Australian state jurisdictions and international approaches (including Portugal) to reducing harm from illicit drug use, including the relative weighting given to enforcement, health and social interventions;
 - (b) a comparison of effectiveness and cost to the community of drug related laws between Western Australia and other jurisdictions;
 - (c) the applicability of alternate approaches to minimising harms from illicit drug use from other jurisdictions to the Western Australian context; and
 - (d) consider any other relevant matter.
- (3) The Select Committee is to report no later than twelve months after the motion is agreed to.
- (4) The Select Committee shall consist of five members; Hon Alison Xamon (Chair); Hon Samantha Rowe (Deputy Chair); Hon Colin de Grussa; Hon Michael Mischin; and Hon Aaron Stonehouse

Debate ensued.
