1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Barry House, took the Chair and read prayers.

2. Statement by President — Parliamentary Research Program

The President made the following Statement —

I take this opportunity to announce the commencement of the 2016 parliamentary research program—formerly parliamentary internship program—coordinated by the Parliamentary Education Office. The program is a cooperative arrangement between the Parliament of Western Australia and Western Australian universities, and involves high-performing students undertaking research topics nominated by Members of Parliament. Each Member will have recently received guidance notes for the program and an invitation to submit up to two research topics to the Parliamentary Education Office by close of business on Thursday, 31 March 2016.
