9. Perth Theatre Trust Amendment Bill 2014

The Minister for Culture and the Arts, pursuant to notice, moved,

That a bill for "An Act to amend the *Perth Theatre Trust Act 1979*." be introduced and read a first time.

Question put and passed.

The Minister for Culture and the Arts presented an explanatory memorandum and bill read a first time.

The Minister for Culture and the Arts moved, That the bill be now read a second time.

Mr D.A. Templeman moved, That the debate be adjourned.

Question put and passed.

10. Electoral Amendment Bill 2014

The Order of the Day for the resumption of the debate upon the second reading of the bill was read. Debate resumed.

Speaker's Statement – Absolute Majority at Second and Third Readings

The Speaker advised members that it was his view that the second and third readings of the Electoral Amendment Bill 2014 needed to be passed with the concurrence of an absolute majority of the members of the House; that is, 30 members.

The Speaker's view was based on section 16M of the *Electoral Act 1907* which states that a Bill which alters certain provisions of Part IIA of the Act, which this Bill did, requires an absolute majority to pass the second and third reading stages.

In this case, the Speaker advised members that he would follow the procedure used in determining whether an absolute majority was in favour of a suspension of standing orders without notice. Under that procedure, he would announce that if there was a dissentient voice when putting the question on the second or third reading, he would divide the house. If there was no dissentient voice, the Speaker would count the members present and declare the question to be carried by an absolute majority if that was the case.

Question put.

The Speaker having counted the House, and an absolute majority being present and there being no dissentient voice, declared the question for the second reading of the bill to be carried with the concurrence of an absolute majority of the whole number of members of the House.

Bill read a second time.

Mr W.J. Johnston moved,

Page 3, lines 15 and 16 – To delete ", protections and immunities".

The Leader of the House moved, That the debate be adjourned.
