WEDNESDAY, 24 FEBRUARY 2010

#### 1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

The Speaker took the Chair.

Prayers were read.

#### 2. Petitions

Commercial Growing of Genetically Modified Canola – Petitions requesting that the Legislative Assembly reverse the decision to allow commercial growing of genetically modified canola in Western Australia were presented by –

Ms A.J.G. MacTiernan from 20 persons (P. 214); and

Mr C.J. Tallentire from 119 persons (P. 215).

Urban Development South of the Moore River – Petitions requesting that the Legislative Assembly support the recommendation that the land adjoining the proposed Wilbinga Conservation Park be protected from future development were presented by –

Mr C.J. Tallentire from 136 persons (P. 216);

Mr J.C. Kobelke from 146 persons (P. 217); and

Mr G.A. Woodhams from 117 persons (P. 218).

#### **7. Pay-roll Tax Assessment Amendment Bill 2010**

The Treasurer, pursuant to notice, moved,

That a bill for “An Act to amend the *Pay-roll Tax Assessment Act 2002* and the *Pay-roll Tax Assessment Regulations 2003.*” be introduced and read a first time.

Question put and passed.

The Treasurer presented an explanatory memorandum and bill read a first time.

Ordered, That the second reading of the bill be made an Order of the Day for the next sitting of the Assembly.

#### **8. Hairdressers Registration (Amendment and Expiry) Bill 2010**

The Minister for Commerce, pursuant to notice, moved,

That a bill for “An Act to amend the *Hairdressers Registration Act 1946* and for related purposes.” be introduced and read a first time.

Question put and passed.

The Minister for Commerce presented an explanatory memorandum and bill read a first time.

Ordered, That the second reading of the bill be made an Order of the Day for the next sitting of the Assembly.

#### **9. Premier’s Statement**

The Order of the Day for the resumption of the debate upon the question, That the Premier’s Statement be noted, was read.

Debate resumed.

Mr E.S. Ripper moved, To add the following words –

“ and that the House condemns the Liberal-National Government for its failure to properly manage the State’s finances driving the State budget into deficit and threatening family budgets, jobs and services

”.

Debate ensued.

Debate interrupted by the Chair (Mr M. McGowan speaking) and adjourned until a later stage of the sitting.

The Leader of the House moved, To insert after “forthwith” the words –

“ subject to the time limits for a Matter of Public Interest ”.

Amendment put and passed.
