**MOTIONS**

**1. Disability Services** (*Notice given 19 June 2013, amended 19 November 2014*)

Continuation of remarks Hon Amber-Jade Sanderson — 25 mins (Wednesday, 18 February 2015) on the motion of Hon Alanna Clohesy as follows –

That this Council condemns the Barnett Government for its lack of leadership in the area of Disability Services and calls on the Government to put people before politics and adequately and sustainably fund services and operate trials and evaluations in a transparent and accountable way.

**2. Waterways — Environmental Degradation** (*Notice given 19 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its failure to take effective action to protect Western Australia's rivers, estuaries and inlets from environmental degradation.

**3. Indigenous Suicide** (*Notice given 19 June 2013*)

Hon Stephen Dawson: To move –

That this Council —

- (a) condemns the Barnett Government for its failure to combat the rise in suicide rates amongst Western Australia's indigenous population; and
- (b) calls on the Ministers for Aboriginal Affairs and Mental Health to outline to the House the strategies they will use to tackle the State's suicide rates.

**4. Review of the RSPCA** (*Notice given 13 June 2013, re-ordered 27 February 2014*)

Hon Rick Mazza: To move –

That the Council supports an investigation into the operations of the RSPCA, including an examination of its government funding, objectives and use of its powers.

**5. Crop Risk Mitigation Product** (*Notice given 19 June 2013*)

Hon Darren West: To move –

That this Council calls on the Barnett Government to support the introduction of a Crop Risk Mitigation Product into Western Australia.

**6. Homeswest — Maintenance** (*Notice given 19 June 2013*)

Hon Samantha Rowe: To move –

That the Council calls on the Government to conduct an independent and transparent enquiry into the Department of Housing with reference to the response time for maintenance and repairs of Homeswest tenants.

**7. Fiona Stanley Hospital** (*Notice given 19 June 2013*)

Hon Amber-Jade Sanderson: To move –

That the Council condemns the Government for its mismanagement of the establishment of Fiona Stanley Hospital and calls on the Government to release all details of its dealings with Serco on the Fiona Stanley Hospital contract.

**8. Indigenous Communities — Safe Drinking Water Supplies** (*Notice given 19 June 2013*)

Hon Stephen Dawson: To move –

That this Council condemns the Barnett Government for its failure to provide safe drinking water supplies to all indigenous communities throughout the Mining and Pastoral Region.

**9. Domestic Assault — Support Services** (*Notice given 19 June 2013*)

Hon Alanna Clohesy: To move –

That this Council notes the significant increase of reported domestic and other assaults in our community and calls on the Barnett Government to immediately commit to boost funding to enable the expansion of support services for women and children seeking to leave abusive or violent relationships.

**10. Container Deposit Scheme** (*Notice given 19 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its failure to introduce a container deposit scheme in Western Australia.

**11. Muresk Facility** (*Notice given 19 June 2013*)

Hon Darren West: To move –

That this Council notes the failure of the Barnett Governments' policy in terms of developing the facility at Muresk as a 'Centre of Excellence' in regard to the provision of a tertiary agribusiness degree and the establishment of the Western Australian Mining Academy (WAMA).

**12. Children's Hospital — Planning and Analysis** (*Notice given 19 June 2013*)

Hon Amber-Jade Sanderson: To move –

That the Council calls on the Government to engage in thorough analysis and planning regarding the potential demands on the New Children's Hospital. Noting that with the significant population growth in Western Australia, it is incumbent on the Government to review current plans and estimates with a view to increasing bed capacity in the new hospital.

**13. Public Transport for Perth in 2031 — Draft Plan** (*Notice given 19 June 2013*)

Hon Ken Travers: To move –

- (1) That the Council notes that —
  - (a) the Liberal/National Government released in July 2011 a “Draft for Consultation” of their plan “Public Transport for Perth in 2031”;
  - (b) the draft plan proposed two transformational projects by 2020 —
    - (i) the fast-tracking of the Northern Suburbs Railway extension to Yanchep; and
    - (ii) construction of a Central Northern Corridor/Curtin/UWA Light Rail;
  - (c) the draft plan identified that the following infrastructure was required in the next five to ten years —
    - (i) a new rail station at Karnup (near Paganoni Road);
    - (ii) upgrades to Canning Bridge and Stirling Stations; and
  - (d) the draft plan proposed a number of on-road Bus Rapid Transit projects be built by 2020, commencing with a Bus Rapid Transit system between Ellenbrook and Bassendean and across to Morley.
- (2) That this Council calls on the Government to —
  - (a) explain why it has taken two years to release the final version of this plan;
  - (b) outline whether it is still committed to the projects and the timelines outlined in the draft plan; and
  - (c) provide detailed reasons, including passenger modelling, for any changes they have made to priority projects or their timing.

**14. Review of the *Firearms Act 1973*** (*Notice given 12 June 2013, re-ordered 27 February 2014*)

Hon Rick Mazza: To move –

That the Council supports an investigation and review of the Firearms Act 1973, with particular reference to interstate visitor temporary permits, pensioner discounts, classification of ammunition components and the length of time it takes to process applications.

**15. Taxi Drivers — Probationary System** (*Notice given 19 June 2013*)

Hon Ken Travers: To move –

That the Council calls on the Barnett Liberal Government to explain why it will have taken more than three years to introduce a demerit point and probationary system for taxi drivers.

**16. Environment Portfolio** (*Notice given 20 June 2013*)

Hon Simon O’Brien: To move –

That this House congratulates the Liberal–National Government on its excellent performance in the environment portfolio.

**17. Great Southern Region** (*Notice given 20 June 2013*)

Hon Colin Holt: To move –

That this Council commends the Liberal–National Government on recognising the importance of the Great Southern Region of Western Australia and applauds the work done by this Government to support the communities of that region.

**18. Education Portfolio** (*Notice given 20 June 2013*)

Hon Liz Behjat: To move –

That this Council congratulates the Liberal–National Government on its excellent performance in the education portfolio.

**19. Royalties for Regions — Pilbara Cities** (*Notice given 20 June 2013*)

That this Council congratulates the Liberal–National alliance government on its acknowledgement and support of the Mining and Pastoral Region and recognises the contribution Royalties for Regions has made to creating better and safer communities in regional Western Australia.

That the Council supports an investigation and review of the fishing rules in Western Australia, with particular reference to bag limits, boat limits and transportation of possession limits.

Hon Alyssa Hayden: To move –

That this Council congratulates the Liberal–National Government on its ability to provide ongoing high quality services and care to the Western Australia community in the health portfolio.

**30. Regional Development — South West Region** (*Notice given 20 June 2013*)

Hon Colin Holt: To move –

That this Council commends the Liberal–National Government on delivering outstanding regional development outcomes in the South West Region of Western Australia.

**31. Mental Health Portfolio** (*Notice given 20 June 2013*)

Hon Nick Goiran: To move –

That this Council congratulates the Liberal–National Government on its excellent performance in the mental health portfolio.

**32. Royalties for Regions — Investment in Regional WA** (*Notice given 20 June 2013*)

That this Council congratulates the Liberal–National alliance government for its forethought and planning by adopting the Royalties for Regions program, which has allowed regional Western Australia to be prepared for major investment opportunities throughout the Mining and Pastoral Region, further supporting the people who chose to live, work and invest in regional Western Australia.

**33. Native Forest — Climate Change** (*Notice given 25 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its continuing failure to protect Western Australia's remaining native forest from the effects of climate change and disease.

**34. State Infrastructure Plan** (*Notice given 25 June 2013*)

Hon Ken Travers: To move –

That this Council —

- (a) expresses its concern at the failure of the Liberal/National Government to develop a long term State Infrastructure Plan for Western Australia;
- (b) notes that the lack of long term planning can lead to poor investment decisions being made in the expenditure of scarce Government funds; and
- (c) therefore, we call upon the Government to immediately commence the development of a long term State Infrastructure plan and to ensure that its development involves —
  - (i) wide community consultation to identify priority infrastructure projects;
  - (ii) the inclusion of major infrastructure projects is based on a comprehensive assessment of their relative benefit to cost ratios; and
  - (iii) the plan is developed in an open and transparent process.

**35. James Price Point — LNG Processing Plant** (*Notice given 25 June 2013*)

Hon Stephen Dawson: To move –

That this Council —

- (a) condemns the Premier for his lack of leadership in securing an outcome in benefits for the indigenous communities in relation to the James Price Point LNG processing plant; and
- (b) calls on the Barnett Government to honour the agreement signed with the Goolarabooloo Jabbirr Jabbirr Traditional Owners to deliver the Kimberley Benefits package.

**36. Apprentices and Trainees in Training** (*Notice given 25 June 2013*)

Hon Alanna Clohesy: To move –

That this Council condemns the Barnett Government for its disregard for the future of young Western Australians and calls on the Government to commit to making substantial increases (beyond pre-Global Financial Crisis levels) in the number of apprentices and trainees in training, especially numbers in trades training.

**37. Disability Justice Centres — Kiara and Caversham** (*Notice given 25 June 2013*)

Hon Amber-Jade Sanderson: To move –

That this Council —

- (a) notes the significant community response to the proposed Disability Justice Centres in Kiara and Caversham, and the lack of consultation with the affected communities;
- (b) calls on the Minister for Disability Services to immediately stop the current process for placing these centres in those locations; and
- (c) instigate a genuine and thorough community consultation process, with the communities surrounding the proposed centres;
  - (i) the process should include a community reference group, consisting of (but not limited to) representatives of residents, representative of Lockridge SHS and Primary School, Corrective Services, Disability Services Commission, the Minister or her representative; and
  - (ii) any final decision should be made with consideration for the communities' concerns and within the guidelines already set for the locating of these centres.

**38. Threatened Species Recovery Plans** (*Notice given 25 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its failure to resource threatened species recovery plans.

**39. Coastal Communities — Climate Change** (*Notice given 26 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its failure to address climate change and sea level rise impacts on our coastal communities.

**40. Environmental Offsets Register** (*Notice given 26 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its failure to implement an environmental offsets register that takes effect from the Government's endorsement of its Offsets Policy released in September 2011.

**41. Proposed New Football Stadium** (*Notice given 27 June 2013*)

Hon Ken Travers: To move –

That this Council directs the Leader of the House to table within six sitting days a copy of all minutes, notes or other records of any meetings between the Premier Hon Colin Barnett and members of the Western Australian Football Commission at which a proposed new stadium was discussed.

**42. Environmental Agencies — Funding** (*Notice given 27 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its failure to fund its environmental agencies to ensure adequate environmental regulation.

**43. Pastoral Lands — Sustainability** (*Notice given 27 June 2013*)

Hon Sally Talbot: To move –

That this Council condemns the Barnett Government for its failure to assess the viability and ecological sustainability of Western Australia's pastoral lands as a basis for future land use beyond 2015.

Hon Ken Travers: To move –

That not later than the rising of the House on the third sitting day following the day on which this order is made, the Leader of the House lay on the Table the following documents in their entirety and without excision or deletion —

- (a) all draft pages of the 2012-13 Government Mid-Year Financial Projections Statements containing the words “Insurance Commission” in the possession of the Department of Treasury on 1 October 2013;

- (c) all file notes or diary entries relating to any conversations between the Treasurer or anyone in their Ministerial office and the Department of Treasury regarding the 2012-13 Government Mid-Year Financial Projections Statements.

**45. TAFE Budget** (*Notice given 17 June 2014*)

Hon Lynn MacLaren: To move –

That the Legislative Council –

- (a) notes that the proposed cuts to the TAFE budget in Western Australia will have disastrous impacts on staff and students and the State's economic future, social well-being and cohesion, and that changes to TAFE have a particularly adverse impact on people in regional and rural parts of the State, disadvantaged communities and people with varying abilities; and
- (b) calls on the State Government to protect, support and expand the capacity of the public TAFE system to allow it to continue its historic role in providing high quality technical and further education to Western Australians of all ages and backgrounds.

**46. Aboriginal People — Wages and Entitlements** (*Notice given 20 August 2014*)

Hon Robin Chapple: To move –

That the State Government note there are many unanswered questions in relation to the wages, entitlements and other monies that were withheld from Aboriginal people living and working on pastoral properties in Western Australia between the years 1905 and 1972, and establish an Inquiry or Royal Commission into the practices of government departments, agencies and officials of the day, as well as pastoral leaseholders, station by station, throughout the State.
