Swan River Trust – Mr C.J. Tallentire presented a petition from 38 persons requesting that the Legislative Assembly calls upon the Barnett Government to recognise the Swan River as a Western Australian icon and to reinstate the Swan River Trust as catchment manager (P. 124).

Takari Primary School – Mr C.D. Hatton presented a petition from 884 persons requesting that the Legislative Assembly requests the Government to install flashing electronic speed signs in the streets adjacent to Takari Primary School (P. 125).

Cockburn Council – Mr F.M. Logan presented a petition from 149 persons requesting that the Legislative Assembly calls on the State Government to leave the City of Cockburn's current boundaries in place (P. 126).

17. Section 18C of the Racial Discrimination Act 1975

Ms M.M. Quirk, pursuant to notice, moved,

That this House expresses its deep regret that the Barnett Government:

- (a) unlike the Governments of New South Wales and Victoria, failed to defend the interests of the residents of this the most multicultural state in the country by lodging a submission opposing the proposal by the Commonwealth to repeal section 18C of the *Racial Discrimination Act 1975*; and
- (b) failed to publicly acknowledge that the proposed changes threaten the social cohesion and well-being of Western Australia's culturally and religiously diverse communities.

Debate ensued.

Debate interrupted by the Chair (Mr F.A. Alban speaking) and adjourned until a later stage of the sitting.
