(d) is the Minister also aware that Mr Ungiljung and many other Kimberley Aboriginal people want the Government to apologise and make proper amends for presiding over the policies that allowed for the withholding of income from Aboriginal people by institutions, businesses and the Government itself for many years, and that he would like the Minister to imagine what that feels like and what sort of restitution the Minister would seek if the situation were reversed?
