# 7. Standing Committee on Procedure and Privileges - Appointment of Members

The Leader of the House moved, without notice -

That the following Members be appointed to the Standing Committee on Procedure and Privileges -

- Hon Giz Watson;
- Hon Wendy Duncan; and
- Hon Nick Goiran.

Debate ensued.

Hon Sue Ellery moved to amend the motion as follows -

(1) To delete "Hon Giz Watson" and insert -

Hon Ken Travers

and

(2) To insert at the end of the motion the following -

and the following Members be appointed as co-opted Members to the Procedure and Privileges Committee -

- Hon Giz Watson: and
- Hon Michael Mischin.

Point of Order

The Leader of the House raised the following Point of Order -

The deletion of "Hon Giz Watson" and the substitution of "Hon Ken Travers" is in fact a direct negative of the motion that I have moved and therefore is not an amendment of the sort we would normally accept.

President's Ruling

The President ruled as follows -

I do not believe the amendment is a contradiction, because it is merely seeking to substitute the names of some members with others, and where Hon Giz Watson's name occurs in both instances, it is in a different capacity in the amendment as a co-opted Member rather than as a substantive Member. I will let the amendment stand.

Debate resumed.

Pursuant to SO 160, Hon Sue Ellery requested that a ballot be conducted to elect Members to the Standing Committee on Procedure and Privileges.

Point of Order

The Leader of the House raised the following Point of Order -

The ballot I presume is for three members. So I wonder whether the fact that the Leader of the Opposition has moved an amendment that in effect makes it five members should be dealt with, or whether the ballot will be just for the three positions that currently exist on the committee.

President's Ruling

The President ruled as follows -

To assure all members of exactly where we are at, the ballot would be according to clause 7.2 of the terms of reference of the Procedure and Privileges Committee, which states -

The Committee consists of 5 Members, including the President and the Chair of Committees, and any Members co-opted by the Committee whether generally or in relation to a particular matter. The President is the Chair, and the Chair of Committees is the Deputy Chair, of the Committee.

Therefore, the ballot would be for three names to fill that committee, because the President and the Chair of Committees are part of that committee.

The President left the Chair at 2.53pm The President resumed the Chair at 3.10pm

Statement by President

The President made the following Statement -

Members, a ballot being called for, I asked for a division. I ask that the bells be rung. [Bells rung.]

Members, initially I asked that the staff circulate the ballot papers. Before Members rush to print, I will explain the method as staff circulate the ballot papers. You are being asked to put three names on your ballot papers. What has happened here today has already exposed an anomaly in our Standing Orders. Unlike as occurs for the election of President and Chair of Committees, there is no nomination process. To overcome that, I will permit the leaders of the various parties, if they wish, to stand and put to the House their suggestions for the Members they wish to be included on the Standing Committee on Procedure and Privileges. That will be one of the first issues that the new committee has to consider in reviewing the Standing Orders.

The method of voting will be as per Standing Order 160(2)(f) and (g), which states -

- (f) the Members who receive the most votes shall be declared by the President to be elected:
- (g) if 2 or more Members have an equality of votes for the last place or places on the Committee, a second ballot shall be conducted to determine that place or those places;

Members have four names from which to choose. For example, if one Member gets 10 votes, one gets eight votes, one gets six votes and another gets four votes, the Members with 10, eight and six votes will be declared elected. If the result is that one Member gets 10 votes, one gets eight votes and two get five votes, the Members who get 10 votes and eight votes respectively will be declared elected and there will be another run-off ballot for the third position.

The ballot papers have been distributed. It is a secret ballot. The ballot box will then be sent around for the collection of votes.

The Leader of the House moved -

That Hon Giz Watson, Hon Wendy Duncan and Hon Nick Goiran be nominated.

Hon Sue Ellery moved -

That Hon Ken Travers, Hon Giz Watson and Hon Michael Mischin be nominated.

There being no further nominations, each Member so proposed having submitted themselves to the will of the Council, the Council proceeded to a Ballot.

The Clerk and Deputy Clerk acted as scrutineers.

The President announced that as a result of the Ballot, That Hon Giz Watson, Hon Wendy Duncan and Hon Nick Goiran had been elected to the Standing Committee on Procedure and Privileges.

## Point of Order

Hon Ken Travers raised the following Point of Order -

I noticed you having a vote, Mr President. I am not questioning that in any way, but it is something that needs to be considered by the committee as part of its review, unless you wish to make a ruling on it at this stage. I am not necessarily asking for that ruling; I am just raising it for future consideration and deliberation as to whether the President would get a deliberative vote or only a casting vote in ballots.

### President's Ruling

The President ruled as follows -

I did vote during that ballot because I took it that every one of the 36 Members who was in the chamber was entitled to vote on a ballot. I think that is a point that will be noted by the Procedure and Privileges Committee in its review.

#### 8. Local Government Council Reform

Motion No. 1 having been called, Hon Ljiljanna Ravlich continued her introductory remarks in moving the motion as follows -

That this Council calls on the Minister for Local Government to explain why he has not been able to achieve local government council reform and to provide details on how much has been spent to date on this failed government policy.

Debate ensued.

# 11. Roe Highway Stage 8

Motion No. 2 having been called, Hon Lynn MacLaren, pursuant to notice, moved -

That, for the purposes of —

- (a) saving the Beeliar wetlands by preserving ecological linkages and a range of other key values including
  - (i) regionally significant vegetation, which is becoming rare as a result of encroaching urbanisation;
  - (ii) habitat for a great many fauna species, especially internationally and nationally significant migratory birds, as well as seriously threatened species like the Carnaby's Cockatoo and the Graceful Sun Moth; and
  - (iii) residential amenity, recreation and education; and
- (b) protecting our unique Aboriginal heritage; and
- (c) redirecting funds into more sustainable transport solutions, such as an expanded rail freight system and a passenger light rail network,

this House calls upon the Barnett Government to abandon the proposed Stage 8 of the Roe Highway development, and to request the Western Australian Planning Commission to initiate an amendment to the Metropolitan Region Scheme in order to delete the current zoning for a road reserve over the area of the proposed Stage 8 of the Roe Highway development.
