In March this year, the Government announced Georgiou Group, Lend Lease Engineering and the OHL/York Joint Venture had been shortlisted to provide concept designs for the new Mandurah bridge. They had until June 23 to submit an application to the Government. I now ask:

(a) when will the design concepts be released to the public for public comment;

- (b) once released for public comment will there be an option to change any of the concept designs;
- (c) what is the timeline for the concept design to be accepted; and
- (d) once the final design has been approved what is the construction time line?

#### 4311. Mr R.H. Cook to the Minister for Health:

- (1) Where is the \$1.2m capital funding and \$500,000 in recurrent funding for the restricted services to be provided by the Marie Stopes Clinic, previously you have indicated it was not coming out of the \$360m budget allocation for the Midland Health Campus and it has required new and additional funding? This new and additional extra money does not appear to be in the budget, will it be in the mid-year review?
- (2) What is the duration of WA Health's contract with Marie Stopes?
- (3) Marie Stopes does not currently do hysterectomies, will patients needing hysterectomies for sterilisation have to go to King Edward Memorial Hospital?
- (4) Marie Stopes Clinic does not perform late term terminations, will patients requiring these services be referred to King Edward Memorial Hospital?
- (5) Were any costings done on providing restricted services at Kalamunda Hospital. If so, would it have been cheaper/or comparable to provide these services at Kalamunda?
- (6) Was any extra consideration or weight given to the fact Kalamunda has the potential to give both greater anonymity to patients and greater security (eg. people could be at Kalamunda presenting for any type of day surgery, whereas the Marie Stopes clinic is dedicated to providing contraception, termination and sterilisation services and regularly experiences protestors outside the front of the clinic)?

#### 4312. Mr R.H. Cook to the Minister for Health:

- (1) I refer to the total budget allocation of \$3.3m in the 15/16 State Budget for the new car park at Osborne Park Hospital. The Government first announced \$5.5m for a new 500 bay car park at Osborne Park back on 18 February 2013, but in the 2013/14 budget only \$3.5m was allocated for this project. This budget shows the total allocation for the carpark has been reduced again to just \$3.3m. Why has the budget for this been reduced further?
- (2) Is a smaller car park being constructed, with less parking bays than originally planned, or is a 500 bay car park really being built for \$2.2m less than the original announcement?
- (3) Will this car park be free parking, or paid parking?
- (4) I note that the 15/16 budget pushes money for completion of this project out yet again, from finishing in the 15/16 financial year to pushing \$1m to complete this in the 16/17 financial year. When will the car park be practically completed?
- (5) Will this car park be reserved for staff, general public or a mixture of both, and if a mixture, can you please provide a breakdown of how many bays will be for staff versus bays?

- (f) I understand the overflow of patients for linacs at RPH were being sent to genesis for radiotherapy, at no cost to the patient, up until February this year when the 2 linacs at

- FSH started operating has the State Government re-negotiated a new contract with Genesis for the overflow of public patients requiring radiotherapy;
- (g) have operating hours of all LINACS in the Perth metro area been extended to cope with current demand until the extra LINACs at FSH are operating at full capacity; and
- (h) the Director General of Health mentioned in the Assembly estimates that a Statewide review of oncology services has just been completed. Can you please provide me with a copy of the review?
