- (i) given the report states that transitions or virtually permanent changes in rangeland resource being recorded are particularly worrying and indicative of totally inappropriate livestock management throughout much of pastoral Western Australia, does the Minister believe that the Rangeland Condition Monitoring system, whereby the pastoral lessee is responsible for assessing and reporting on rangeland conditions on their pastoral leases, is effectively enabling pastoral lessees to use methods of best pastoral and environmental management practice for the conservation and regeneration of pasture for grazing;
