1. Meeting of Assembly

The Speaker advised members a computer virus had penetrated Parliament's Information Technology network despite sophisticated firewall virus protection, and that the network was currently off line. This affected a number of House operations, including Hansard publications, the preparation and processing of Questions on Notice and answers to Questions on Notice. Members were advised that Hansard would be able to record the proceedings of the Chamber and Committees, but members would not receive copies of their speeches until the network had been restored.

The Speaker advised members that he had approved the presence of media at the north and south doors of the Chamber and in the Public and Press Galleries for the first ten minutes of Question Time to take photographs and footage of the new seating arrangements.
