## **THURSDAY, 12 OCTOBER 2017**

### 1. Meeting of Council

The Council assembled at 10.00am pursuant to order.

The President, Hon Kate Doust, took the Chair and read prayers.

## 2. Statement by President — Protocol for Parties Swapping Allocated Non-Government Business Days

The President made the following Statement —

Members, since 2012, sitting Thursday mornings are set aside for Non-Government Members' Business and Private Members' Business. The Standing Orders provide that the weekly rotation schedule for each set of business "shall be tabled by the President at the commencement of each Parliament, and otherwise as required, and must be adopted by the Council prior to its application".

A new weekly rotation schedule is adopted at the start of each year, and during the year following confirmation of the dates of the estimates hearings.

Nevertheless, the following practices of the House result in the weekly rotation schedules becoming an inaccurate record:

- (a) special adjournment motions not to sit on a particular Thursday; or
- (b) suspension of Standing Orders so as to cancel Non-Government Members' or Private Members' Business on a particular Thursday; or
- (c) Members may decide against using their allocated session and not submit an item of business by the deadline; or
- (d) two parties may informally agree to 'swap' their allocated sessions.

It is this last practice that occurs the most infrequently (only four times for Non-Government Business since 2012), but is the most likely to cause confusion or result in a point of order.

Parties to these swap arrangements wish to keep them informal and flexible, and have indicated a preference against swaps requiring adoption by, or the leave of, the House. Nevertheless, there seems to be agreement that there needs to be a record of these arrangements and that, where possible, the schedules should be capable of being updated to reflect them.

In the long term it may be necessary to amend Standing Orders 111 and 112 to formally recognise swap arrangements. However, in the interim, I am satisfied that swap arrangements have become an accepted practice of the House. What needs to be addressed, however, is the lack of any formal record of these arrangements and the lack of notice to the House.

I understand that Hon Aaron Stonehouse has entered into an agreement with the Liberal Party whereby he has swapped his allocated Non-Government Business session this Thursday, 12 October 2017, for the Liberal Party's allocated session on Thursday, 7 December 2017. That arrangement is now on the record.

Where swap arrangements occur in the future, I request that each of the parties involved write to me confirming the arrangement prior to the Tuesday of the first sitting week affected. I will then table the letters at the first available opportunity so that there is a formal record of the arrangement and that sufficient notice is given to the House.

The Non-Government Business Schedule on the website will be updated to provide an accurate record.
