Hon Robin Chapple presented Report No. 73 of the Joint Standing Committee on Delegated Legislation giving notice to the Legislative Council, pursuant to Standing Order No. 179(2), of a resolution of the Committee on 10 September 2014 to commence an Inquiry into the Proposed Template Waste Local Law. ## 9. City of Greater Geraldton Animals, Environment and Nuisance Local Law 2014 — Disallowance

Hon Robin Chapple: To move on the next day of sitting —

That, pursuant to recommendation of the Joint Standing Committee on Delegated Legislation, the *City of Greater Geraldton Animals, Environment and Nuisance Local Law 2014* published in the *Gazette* on 13 May 2014 and tabled in the Legislative Council on 17 June 2014 under the *Local Government Act 1995*, be and is hereby disallowed. (Tabled Paper 1484).

#### 10. Local Government Amalgamations

Hon Ken Travers: To move on the next day of sitting —

That this House —

- (a) expresses its view that the *Local Government Act 1995* (the Act) never contemplated the use of boundary changes to amalgamate Local Governments:
- (b) believes that the correct approach under the Act is to abolish existing Local Governments and to create new Local Governments as this ensures that local communities are given a voice as intended by the Dadour provisions of the Act;
- (c) is of the view that any attempt to force Local Government amalgamations by using boundary changes to circumvent the intent of the Dadour provisions is an abuse of the Act; and
- (d) therefore calls on the Government to ensure that any proposals for amalgamation of existing Local Governments involve the abolition of all affected Councils and the creation of new Councils.

#### 11. Marine Parks in Western Australia — Amendment to Notice of Motion

Hon Rick Mazza, pursuant to Standing Order 62(a), amended Motion No. 2 to read as follows –

That the Council supports —

- (a) a moratorium on the creation of any further marine parks in Western Australia; and
- (b) an investigation into the access to and management of the current marine parks in Western Australia, including allowing shore based fishing in sanctuary zones.

#### 12. Vocational-Based Training

Non-Government Business No. 1 having been called, Hon Sally Talbot moved, without notice —

That this House condemns the Barnett Government for undermining vocational-based training through its changes to state training providers, including harsh rises in course fees.

Debate ensued.

#### 13. Mineral Resources Rent Tax — Goods and Services Tax

Private Members' Business No. 1 having been called, Hon Peter Katsambanis moved, without notice —

That this House —

- (a) congratulates the Federal Government on the abolition of the job destroying, anti-Western Australian mining tax, also known as the Mineral Resources Rent Tax; and
- (b) calls on the Federal Government to take urgent steps to abolish the current flawed system for the distribution of Goods and Services Tax (GST) revenue amongst the Australian states, and implement a new population-based system that provides Western Australia with its fair share of GST revenue.

Debate ensued.

Motion lapsed.

The Attorney General on behalf of the Minister for Agriculture and Food representing the Minister for Mines and Petroleum tabled an Explanatory Memorandum relating to the Bill. (Tabled Paper 1847). Debate stands adjourned.

#### 8A. Advance health directive

- (1) Notwithstanding anything in this Act to the contrary, the scheme of the *Guardianship and Administration Act 1990* relating to advance health directives must be followed in its entirety in order to give them full force and effect.
- (2) A psychiatrist must not act contrary to an advance health directive unless the State Administrative Tribunal has determined that the psychiatrist can do so.
- (3) The State Administrative Tribunal shall have jurisdiction to make a determination in subsection (2) and shall, in exercising this jurisdiction, follow the provisions of the *Guardianship and Administration Act 1990*.

- (g) informing the person about any research relationship between any medical practitioner and any mental health service that may be relevant to the admission or treatment.
