#### **4. Community Development and Justice Standing Committee – Terms of Reference**

The Speaker advised members that he had received a letter dated 7 May 2014 from Ms M.M. Quirk, Chair of the Community Development and Justice Standing Committee, advising that the Committee had resolved to initiate an inquiry into the policy implications of an ageing community with the following terms of reference:

The Committee will examine:

- (1) the effectiveness of the Seniors Strategic Planning Framework 2012–2017 in guiding policies and programs to create age-friendly communities throughout the State; and
- (2) the extent to which age-friendly communities have been established in WA.

The Committee will report on this inquiry to the House by 25 September 2014.

#### **5. Community Development and Justice Standing Committee – Terms of Reference**

The Speaker advised members that he had received a letter dated 13 May 2014 from Ms M.M. Quirk, Chair of the Community Development and Justice Standing Committee, advising that the Committee

had resolved to conduct an agency review hearing with WA Police into the conduct of the investigation of traffic incidents involving the member for Vasse on or about 23 February 2014.

The review will be conducted on 19 May 2014 with the following terms of reference:

- (1) police communications and integration of information related to the incident;
- (2) investigations undertaken by police officers on the night in question;
- (3) the nature of demand for police attendance on the night in question;
- (4) the subsequent conduct of the investigation and collection of evidence; and
- (5) the decision to prosecute, the charges laid and legal advice sought.

The Committee will report on this review to the House by 12 June 2014.

Photo ID Card – Ms M.M. Quirk presented a petition from 10 persons requesting that the Legislative Assembly urges the Premier and the Government to provide aged pensioners with the Photo ID Card free from any government charges (P. 131).

Burswood Peninsula – Mr J.E. McGrath presented a petition from 3,533 persons requesting that the Legislative Assembly opposes the annexing of the Burswood Peninsula to the City of Perth (P. 132).
