MOTIONS

1. Government Tourism Policy (*Notice given 19 March 2009*)

Continuation of remarks Hon Robin Chapple - mins 30 (Wednesday, 17 November 2010) on the motion of Hon Ljiljana Ravlich as follows -

- (1) That this House condemns the Minister for Tourism for her failure to produce a tourism policy at a time of economic uncertainty and calls on the Minister to outline what she will do to assist tourism businesses and Western Australian workers who are adversely impacted by the global financial crisis.
- (2) That this House calls on the Minister to explain -
 - (a) her Government's policies to deal with the impact of the global financial crisis on tourism operators in Western Australia and the thousands of workers that are being retrenched in the tourism and hospitality sector;
 - (b) what strategies she has put in place to protect small business and their workers;
 - (c) what practical assistance is available to tourism operators that go bust and the thousands of workers who lose their jobs; and
 - (d) why she has been asleep at the wheel whilst tourism operators in Western Australia go under.

2. Review of TAFEWA Operations (*Notice given 19 March 2009*)

Hon Ljiljana Ravlich: To move -

That this House calls on the Minister for Training to provide information to the House on the review of TAFEWA operations, which will among other things, be giving consideration to the level of independence required by TAFE Colleges and the manner in which Colleges can improve and streamline the way business is conducted and asks the Minister to explain -

- (a) who is undertaking this review;
- (b) what are the terms of reference for the review and the timeline for completion;
- (c) why he has been secretive about the review by not announcing it but rather letting it slip under the radar;
- (d) why he was selective in which stakeholders he wrote to about the review in December and why he did not inform the whole sector; and
- (e) why he has not allayed the concerns of the training sector that TAFE colleges will have to contest with each other, be privatised or have their functions contracted out.

3. Rescission of Vote - The Cliffe (*Notice given 8 April 2009*)

Hon Giz Watson: To move -

That this House consider as a matter of grave concern the information withheld from this House when considering the removal of *The Cliffe* from the Register of Heritage Places.

4. High-Level Nursing Home Care - Commonwealth Funding (*Notice given 17 June 2009*)

Hon Helen Morton: To move -

That this House expresses its concern about the impact on families and access to acute hospital beds in Western Australia, of the Federal Government's inadequate capital and recurrent funding arrangements for high level nursing home care.

5. Dampier Archipelago (*Notice given 11 August 2009*)

Hon Robin Chapple: To move -

That this House calls on the Premier to protect the most unique and largest collection of rock art in the world by nominating the Dampier Archipelago to the Federal Government for inclusion in the World Heritage List.

6. Criminal Injuries Compensation Law Reform (*Notice given 11 August 2009*)

Hon Nick Goiran: To move -

That this House condemns the former Attorney General for the gross inadequacies of the Criminal Injuries Compensation law reforms which have not only resulted in the denial of compensation for deserving victims such as the recent case of Police Constable Butcher, but have also reflected a failure on the part of the former Attorney General to place the needs of the victim at the forefront of any such reform.

7. Limitation Act 1935 - Reforms (*Notice given 10 November 2009*)

Hon Nick Goiran: To move -

That this House condemns the former Attorney General for the gross misrepresentation he made regarding his reform of the *Limitation Act 1935* having said that his law reform would make the system fairer.

Hon Adele Farina: To move -

That recommendation Nos 1 and 2 contained in the Forty-Ninth, Fiftieth and Fifty-First Reports of the Standing Committee on Uniform Legislation and Statutes Review be adopted and agreed to.

9. Mental Impairment Court Intervention Program (*Notice given 21 September 2010*)

Hon Alison Xamon: To move -

That this House call upon the Attorney General to urgently adopt Recommendation 23 of the Law Reform Commission Final Report *Court Intervention Programs: Project No. 96* (June 2009), and establish a mental impairment court intervention program in Western Australia.

10. Bush Forever - Metropolitan Region Scheme Amendment (*Notice given 22 September 2010*)

Hon Alison Xamon: To move -

That this House notes the finalisation of the *Bush Forever* Metropolitan Region Scheme Amendment and the associated State Planning Policy 2.8, *Bushland Policy for the Perth Metropolitan Area*, and calls on the Barnett Government to go further and protect Perth's unique urban bushland in perpetuity by -

- (a) guaranteeing statutory protection for those same *Bush Forever* sites;
- (b) legislating, or introducing regulations, which assure an appropriate standard of management for those sites; and
- (c) appropriately funding that management.

11. Renewable Energy Sources - Development (*Notice given 16 November 2010*)

Hon Kate Doust: To move -

That this House calls on the Government to stop taking a half-hearted approach to encouraging and supporting the development and uptake of renewable energy sources and take immediate steps to make sure Western Australia is at the cutting edge of the use of wind, solar, geothermal and wave and tidal power.

12. Culture and Arts Funding (*Notice given 16 November 2010*)

Hon Linda Savage: To move -

That this House calls on the Government to immediately increase funding for Culture and the Arts in Western Australia to compensate for cuts made in the 2009/10 and 2010/11 budgets.

13. Household Fees and Charges (*Notice given 17 November 2010*)

Hon Ken Travers: To move -

That this House condemns the Barnett/Grylls Government for the savage increases in household fees and charges and the abolition of assistance payments to families such as the \$400 "It pays to learn allowance" which has resulted in families being up to \$1 400 worse off.

We note that the savage 46 percent increase in electricity and 30 percent increase in water charges over two years has resulted in an increase in the dividends the State Government is receiving from the power and water utilities.

We say enough is enough and call on the Barnett/Grylls Government to keep future increases to below the rate of inflation.

14. Climate Change Adaptation and Mitigation Strategy (*Notice given 17 November 2010*)

Hon Sally Talbot: To move -

That this House condemns the Government for entering its third year of office without the Climate Change Adaptation and Mitigation Strategy promised by the Liberals before the 2008 election.

15. Marine Park Planning (*Notice given 18 November 2010*)

Hon Sally Talbot: To move -

That this House condemns the Government for taking an old-fashioned, piecemeal and politically-driven approach to Marine Park planning in Western Australia.

16. Water Restrictions (*Notice given 18 November 2010*)

Hon Jon Ford: To move -

That this House calls on the Government to immediately address its mishandling of the water portfolio which has resulted in continuing water restrictions across the metropolitan region and lack of proper planning for an adequate future water supply, particularly for Pilbara communities.

That, for the purposes of —

- (a) Saving the Beeliar wetlands by preserving ecological linkages and a range of other key values including —
 - (i) regionally significant vegetation, which is becoming rare as a result of encroaching urbanisation;
 - (ii) habitat for a great many fauna species, especially internationally and nationally significant migratory birds, as well as seriously threatened species like the Carnaby's Cockatoo and the Graceful Sun Moth; and
 - (iii) residential amenity, recreation and education; and
- (b) protecting our unique Aboriginal heritage; and

- (c) redirecting funds into more sustainable transport solutions, such as an expanded rail freight system and a passenger light rail network,

this House calls upon the Barnett Government to abandon the proposed Stage 8 of the Roe Highway development, and to request the Western Australian Planning Commission to initiate an amendment to the Metropolitan Region Scheme in order to delete the current zoning for a road reserve over the area of the proposed Stage 8 of the Roe Highway development.

 - (b) the relationship between the iron ore policy and the use of state agreements to facilitate the development of iron ore projects;

- (c) the extent to which the iron ore policy has been the subject of review and variation including by the Department of Industry and Resources;
 - (d) whether the existence and terms of the iron ore policy have been adequately disclosed, including to new entrants and potential new entrants into the iron ore industry;
 - (e) the current operation of the iron ore policy including -
 - (i) the impact of the iron ore policy upon -
 - (A) investment in iron ore exploration in the State; and
 - (B) iron ore royalties and other revenues received by the State (in relation to both quantum and time of receipt);
 - (ii) whether the iron ore policy is anti-competitive in the current market in that it prevents the turn-over of ground and thereby -
 - (A) preserves the market power of existing members of the iron ore industry; and
 - (B) operates as a barrier to entry to new entrants into the market;
 - (f) whether the original rationale for the iron ore policy remains applicable today;
 - (g) whether there is still any need to treat iron ore differently to other mineral commodities under the *Mining Act 1978 (WA)*; and
 - (h) whether it is still necessary and appropriate to use government agreements to facilitate the development of iron ore resources or whether the *Mining Act 1978 (WA)* provides an adequate and appropriate vehicle.
