MOTIONS ON NOTICE

1. Publication of Committee Minutes of Meetings — Select Committee on End of Life Choices (*Notice given 23 August 2018*)

Continuation of introductory remarks Hon Nick Goiran — 37 mins (Wednesday, 7 November 2018) in moving the following motion —

- (1) That the Speaker of the Legislative Assembly cause to be Tabled in both the Legislative Council and the Legislative Assembly, within three sitting days of both Houses having so ordered, all minutes of meetings of the Select Committee on End of Life Choices, redacted only to maintain as private the details of any private evidence or personal information; and
- (2) That the Legislative Assembly be invited to pass a resolution in similar terms.

Total time remaining on motion – 3hrs 52mins.

2. Retirement Villages Act 1992 — Reform (*Notice given 18 October 2018*)

Hon Alison Xamon: To move —

That this House —

- (1) Notes the growing ageing population increasingly looking for suitable accommodation options to facilitate ageing in place;
- (2) Calls on the government to reform the *Retirement Village Act 1992* and associated subsidiary legislation as a matter of priority particularly, but not limited to, strengthening provisions in the following areas —
 - (a) definitions;
 - (b) enforceability of a code of conduct;
 - (c) timely action by the Commissioner for Consumer Protection;
 - (d) training of managers;
 - (e) contracts;
 - (f) responsibility for capital maintenance and upgrade/ replacement;
 - (g) refurbishment of residential units on departure from a village;
 - (h) dispute resolution process; and
 - (i) exit fees.
- (3) Calls on the government to engage in extensive consultation with the sector, including the Western Australian Retirement Villages Residents' Association, prior to finalising any proposed legislation.

3. Decriminalising possession of non-lethal means of self-defence (*Notice given 6 November 2018*)

Hon Aaron Stonehouse: To move —

That this House recognise the inherent right of individuals to defend themselves from attack in a timely and measured manner, and calls upon the McGowan Government to decriminalise the sale and possession of non-lethal means of self-defence.
