At the close of nominations, I had received nine formal nominations from qualified persons. A re-count was then conducted in accordance with section 156D(4) of the *Electoral Act 1907*.

Following the re-count and in accordance with section 156D(8)(a) of the *Electoral Act 1907*, I declared Linda Rosemary Savage to be elected as a member of the Legislative Council to fill the vacancy in the East Metropolitan Region.
