# WESTERN AUSTRALIA LEGISLATIVE COUNCIL MINUTES OF PROCEEDINGS No. 56 TUESDAY, 8 MAY 2018

#### 1. Meeting of Council

The Council assembled at 2.00pm pursuant to order. The President, Hon Kate Doust, took the Chair. Prayers and an Acknowledgement of Country were read.

# 2. Statement by President — Acknowledgement of Country

The President made the following Statement —

I would like to acknowledge the presence of a number of esteemed Noongar elders and guests who are in the President's gallery today.

Firstly, I acknowledge Dr Richard Walley and his wife, Robyn Walley. This day marks the first sitting day of the Legislative Council that commences its proceedings with an acknowledgement of country, an acknowledgement that this House honours the traditional owners of the ancestral lands upon which we meet the Whadjuk Noongar people, and pays its respects to their elders both past and present. Dr Walley's advice and counsel was invaluable in progressing this acknowledgement. The Standing Committee on Procedure and Privileges requested Dr Walley's advice at relatively short notice as it sought a respectful and appropriate wording for an acknowledgement of country to recommend to the House. On behalf of the Committee and this House, I would like to put on record our thanks to Dr Walley for his timely and expert advice and assistance. The Parliament of Western Australia and, indeed, the Legislative Council, was the last remaining jurisdiction in Australia to adopt an acknowledgement of country.

I would also like to acknowledge the presence of our other esteemed guests, Dr Robert Isaacs, Ms Sandra Harben and Professor Colleen Hayward, who have all provided significant and longstanding contributions towards recognition for and on behalf of Aboriginal people in Western Australia.

# 3. Statement by President — Dr Paul Lobban

The President made the following Statement —

I would like to record for posterity the passing of a former senior staff member in the Legislative Council. Dr Paul Lobban was appointed Usher of the Black Rod in October 2013 and resigned to return home to Adelaide in 2015 after 19 months of service to this House. He sadly passed away on Monday, 23 April. He was only 48 years of age when he died from motor neurone disease.

Before his role as Usher of the Black Rod in Western Australia, Paul was employed as an executive officer with the Public Works Committee of the House of Assembly in South Australia and had worked at the South Australian Parliament since 2001 in several committee support and administrative roles. He worked closely with some of my ALP colleagues in South Australia, who have told me of his excellent reputation as a committee secretary, good humour

and dedication to the Parliament. Paul was well qualified for his parliamentary career, holding a PhD in literature and a Bachelor of Laws from the University of Adelaide.

As Usher of the Black Rod, Paul managed the Council's papers office and was a Clerk at the Table. During his brief time here he developed strong friendships with many Members and staff from both Chambers. His commitment to his sandgroper friends was demonstrated when he returned briefly to Western Australia to help a colleague celebrate her milestone fiftieth birthday, which is sadly a milestone he himself never reached.

Paul loved Perth and his time here. His sense of humour and his facility for withering commentary were unaffected by his illness, even at the point where he was communicating by means of eye-tracking software.

Paul leaves behind his fiancée, Debbie, and two young children whom he loved very much. A life tragically cut short. We pass on our respects to Paul's family.

# 5. President's Ruling — Questions without Notice No. 271 — Parliamentary Secretaries

The President ruled as follows —

On Thursday, 12 April 2018, Hon Nick Goiran raised a point of order during question time. He has asked me for my ruling as to who was responsible for an answer given by the Parliamentary Secretary to the Minister for Education and Training acting on behalf of the Leader of the House representing the Minister for Child Protection.

Hon Nick Goiran's question without notice 271, C288, with some notice given, was directed to the Leader of the House representing the Minister for Child Protection. The Minister for Child Protection is a Member of the Legislative Assembly, so any answer in this House must be given in a representative capacity. The responsible Minister had authorised the Leader of the House, as her representative in the Council, to provide information by the usual practice of signing a hard copy of the answer. The Leader of the House could not deliver the answer as she was absent from question time due to urgent parliamentary business. To facilitate an answer, the Leader of the House, in her capacity as Minister for Education and Training, directed her Parliamentary Secretary to do so on her behalf. As is the usual practice when answers are given in a

representative capacity, a copy of the answer authorised by the Minister was provided in hard copy to Hon Nick Goiran. In a statement dated 22 March 2016, President House observed —

Ministers and Parliamentary Secretaries answering questions on behalf of the Minister they represent are responsible to this House, I repeat, to this House, for the answer that they give. When given in this place, it is their answer and they are responsible for its accuracy. However, the representative Minister or Parliamentary Secretary is not individually responsible in any legal or parliamentary sense for the department of state of the Minister they are representing. This is made clear by the practice for oral questions when questions are answered in a representative capacity. In these cases the Member asking the question is required to give some notice. This is to enable the responsible Minister in the other place to approve any answer to be given by his or her representative in this House. This approval is provided by the responsible Minister signing the answer. When it is discovered that an answer given in any capacity is inaccurate, the Minister or Parliamentary Secretary has an obligation to correct the record at the earliest opportunity, and the usual practice is to also apologise to the House for the error.

From this statement it is clear in this case that the Parliamentary Secretary is responsible for the answer that she provided to the House, even when she answered on behalf of and as directed by the Leader of the House and in a representative capacity.

The Parliamentary Secretary has a corresponding obligation to correct the record at the earliest opportunity and to apologise to the House if she discovers the answer is inaccurate. By way of further explanation, Ministers individually and the Cabinet collectively, as the Government, are accountable to the Legislative Council. The asking and answering of questions is one procedure intended to achieve accountability of a Government's actions and policies. However, Members of this House may only ask questions of other Members of this House in accordance with the Standing Orders, they cannot ask questions directly of Members in the other place. From a practical point of view, the information sought by Hon Nick Goiran resides in a department overseen by a Minister in the Legislative Assembly. The fact that the Minister for Child Protection has signed off on the answer provided to this House by the Parliamentary Secretary is a demonstration of the Minister's individual accountability to this House and gives the answer its authority.
