1. Meeting of Council

Hon Robin Chapple presented a petition from 38 petitioners requesting the Legislative Council to withdraw the *Aboriginal Heritage Amendment Bill 2014*; establish an inquiry into the Department of Aboriginal Affairs' management of Aboriginal heritage in Western Australia; and form a select committee to develop a proper framework to reform the *Aboriginal Heritage Act 1972* by involving Aboriginal peoples in meaningful ways and by building on previous suggestions from previous reviews. Hon Helen Morton raised the following Point of Order —

I did not quite catch the last comment that was made, although it appears that the Member suggested that I sought to mislead the House. If that was the case, I ask the Member to either formally move that as a concern or withdraw it before I make a further statement.

President's Ruling

The President ruled as follows —

No Member should make an allegation that another Member has misled the House unless they intend to follow that up with a referral to the Standing Committee on Procedure and Privileges. I believe that the Minister for Mental Health has asked for the withdrawal of the last remark about misleading the House. I ask the Member to withdraw that particular remark.

Point of Order

Hon Adele Farina raised the following Point of Order —

The Minister has suggested that I made a statement that I did not make and again has impugned my reputation by suggesting that I have got it wrong, when I have referred to a number of reports that clearly link the rollout of the NDIS with the axing of block funding. If it is necessary, I will table all those documents to which I have referred. I do not have them all with me now, but I will get them overnight and table them tomorrow. I ask that the Minister withdraw her statement, because yet again she is misrepresenting what I said.

President's Ruling

The President ruled as follows —

Members, I believe that the Minister for Mental Health said that it was her recollection that the Member said something to that effect. The standing orders allow for any Member to stand at the conclusion of another Member's contribution to correct the record about what has been said by a previous member and I believe that that is what Hon Adele Farina has done in taking a point of order and making those comments. As to the withdrawal of the remark, I do not consider the remarks were unparliamentary; therefore, I will not insist on their withdrawal. But I invite the Minister for Mental Health to withdraw, if she wishes, as a courtesy or to state her case in response to the point of order.
