1. Meeting of Assembly

The Assembly met at 12.00 noon pursuant to adjournment.

Baker presented a petition from 6,975 persons requesting that the Legislative Assembly takes steps to ensure that no child is ever involuntarily committed or treated and that fully informed parental consent is always required for psychiatric treatment (P. 71).

Avonlink Train Service – Petitions requesting that the Legislative Assembly requests that the Minister for Transport continues to provide the long-distance commuter train from Perth to the Avon Valley and to link the service to the Transporth Smartrider system were presented by –
