The Speaker advised members that there had been a number of incidents recently where members had made inappropriate remarks towards or about the member in the Chair. Standing Orders and the practice of the House made it quite clear that if a member wished to challenge or criticise actions of the Chair, this could only be done by way of substantive motion: casual criticism of the Chair was not permitted. The House did not tolerate remarks whether addressed directly towards the Chair or perhaps made as a 'stage whisper', which reflected on the motives of the member in the Chair, which attacked decisions of the Chair, or which attempted to draw the Chair into the debate. Each of those members who provided service to the House by chairing its proceedings were aware that any such behaviour could not be condoned and should be dealt with firmly. The Speaker asked for all members' cooperation in this common-sense approach.
