13. President's Ruling — Withdrawal of Remark

The President ruled as follows —

Last Thursday I undertook to provide a ruling on a point of order raised by the Hon Helen Morton relating to the attribution to her of certain words by Hon Amber-Jade Sanderson. The claim by Hon Amber Jade Sanderson on Thursday, 23 June 2016 was that the Hon Helen Morton had said certain words by way of interjection the previous day and that the *Hansard* would confirm this.

The words claimed to have been said were, "Well, it was only a hairline fracture", during an interjection to the Hon Amber-Jade Sanderson's speech referring to an elderly patient at Royal Perth Hospital who waited four days for surgery on a fractured leg.

The Hon Helen Morton seeks a withdrawal from the Member who attributed those words to her because in her view the Member had misled the House by claiming the words were attributed to her in the record of debates when they were not. The Hon Helen Morton also sought a withdrawal on the ground that the words claimed to be attributed to her were repeated inaccurately and in a manner that breached Standing Order 45.

At the outset I remind Members that *Hansard* is not omniscient. It cannot and does not record every word said in this Chamber. There are internal guidelines used by *Hansard* to ensure that what we say in this Chamber is placed in a written record which is intelligible and coherent. One such guideline is that generally, only interjections responded to by the Member with the call are reported. Interjections between interjectors are generally not reported. Words that are not heard by the *Hansard* reporter or cannot be determined from the audio or video tape or cannot be attributed to a particular Member are not reported even when responded to. The most common occurrence where words cannot be attributed is when there is an interjection or series of interjections, particularly when they are unruly. At their own peril, Members should not assume that *Hansard* will record and attribute every interjection made in this place.

The *Hansard* record of last Wednesday's debate was only available in uncorrected form at the time when the point of order was raised. The uncorrected *Hansard* did not attribute the words

quoted by the Hon Amber-Jade Sanderson to the Hon Helen Morton or indeed to any Member. The emphatic claim by the Hon Amber-Jade Sanderson that the words she attributed to the Hon Helen Morton were indeed said by that Member appears to be founded on her genuine belief that this would be confirmed in the record of debate at some point. This belief was misconceived. *Hansard* has reviewed the recordings of Wednesday, 22 June 2016. Neither the reporter nor the audio or visual recordings support the contention of the Hon Amber-Jade Sanderson that the words she attributes to the Hon Helen Morton were said by that Member. At no point are they attributed in *Hansard* to the Hon Helen Morton and that Member asserts she did not say the words as quoted by the Hon Amber-Jade Sanderson.

As a matter of logic, just because words do not appear in *Hansard* does not mean that they were not said. The admission by the Hon Helen Morton during Members' Statements last Thursday that she did use the word "hairline" in her interjection is a case in point. However, in the absence of the Presiding Member hearing the words or a recording or transcript containing the words and their clear attribution I cannot satisfactorily resolve the claims and counterclaims as to what precisely was said. However, it is clear that the words quoted by the Hon Amber-Jade Sanderson and attributed by her to the Hon Helen Morton are not supported by the official record. There is no evidence, however, to support the view that the Member or any other Member had an intention to mislead the House. I remind Members that they should not make an allegation that another Member has misled the House unless they intend to proceed with such a claim by substantive motion as a matter of privilege under Chapter Ten of the Standing Orders.

I also take this opportunity to counsel Members on the risks that you take by interjecting on another Member's speech, particularly when multiple persons interject at the same time. By doing so you place yourself at risk of being misunderstood by the Member with the call and perhaps other Members. Complications may flow from such a misunderstanding as has been demonstrated with this matter even where, as in this case, there is no intention on the part of any Member to deliberately misrepresent the facts.

Nevertheless, the Hon Amber-Jade Sanderson's claim that the official record would attribute certain words to the Hon Helen Morton is clearly incorrect. Taken in their context the words may also constitute an inappropriate personal reflection that breaches Standing Order 45 but I will not make that determination unless the usual convention of this House is resisted.

Accordingly, and consistent with the long standing practice in this place I invite the Hon Amber-Jade Sanderson to withdraw those words.
