I refer to voter enrolment in the Pilbara electoral district for the period 30 June 2016 to 30 September 2016, and ask:

- (a) what is the explanation for the disparity between a 22 percent increase in electoral enrolments whilst there is a fifty percent increase in the number of vacant properties; and
- (b) can the Minister outline what analysis the Western Australian Electoral Commission has undertaken as part of the investigation into these irregularities?

- (1) Is the Minister aware of an 18 percent increase in registered voters in the Pilbara for the period 30 June 2016 to 30 September 2016?

- (3) How many voters registered in that period were as a result of changes to the *Electoral Act 1907* allowing direct enrolment?
