2. Statement by President - Emergency Evacuation Procedures

The President made the following Statement -

Tuesday's evacuation alarm was the result of automatic fire detectors activating due to increased smoke in the attic area of Parliament House. The origin of this smoke was subsequently traced to the dining room servery.

Please be advised that the emergency fire alarm procedure is as follows. The initial alarm is an on—off tone that rises in volume. This alerts Parliament House occupants to the existence of an emergency situation and that we should stand by for an evacuation tone or further verbal instructions. At this stage the emergency response team will ascertain the nature of the emergency. A broadcast over the public-address system at regular intervals will state, "Please stand by for further instructions." If the emergency is deemed to be a false alarm, the following statement will be made, "Attention all personnel! Attention all personnel! A fault has been identified as the cause of the alarm. Please disregard the alarm." If the emergency is authentic, a constant on—off tone will sound, including a taped message stating, "Emergency! Evacuate now." At this point all occupants are to vacate the building under the direction of the relevant floor wardens to the muster point on either the tennis courts or the Hay Street grassed area. Full details of the procedures are located in the 'If' booklet which is located behind each Member's office door, which I am sure all Members have read.
