MINUTES OF PROCEEDINGS

TUESDAY, 23 OCTOBER 2012

1. Meeting of Council

The Council assembled at 3.00pm pursuant to order.

The President, Hon Barry House, took the Chair and read prayers.

2. Distinguished Visitor — Speaker of the Cook Islands Parliament

The President drew attention to the presence in the gallery of Hon Niki Rattle, Speaker of the Parliament of the Cook Islands, and, on behalf of Honourable Members, extended a warm welcome to her.

3. President's Ruling — Oral Reports of Committees during Members' Statements

The President ruled as follows —

During Members' Statements last Thursday a point of order was raised regarding the comments by Hon Philip Gardiner. The question was whether the Member was making a private statement or reporting from a committee; and, if so, whether that was in order.

Standing Orders, while not comprehensive, lay down certain procedures that must be followed. For Committees the proper process for reporting to the House is by presenting a written report to the House. Standing Order 20(3) provides that the Chair of a Committee, or another Member of the Committee appointed for the purpose, may present a report at any time when there is no other business before the House. Once presented, the reports become an order of the day for Members' consideration. In addition, on tabling a report the Chair has the opportunity to make a three-minute statement to outline the content of the report. This is the proper process to be followed. Members would be aware that the Standing Committee on Procedure and Privileges considered this matter in its twenty-fourth report and made the following observation at paragraph 4.11.12 —

In effect, this practice of delivering a verbal report to the Council does not conform with Standing Order 188, which is predicated upon a written report being presented and tabled. Further, the business item before the Council at the time of the delivery of these reports, presentation of papers for tabling (SO 14(1)(f)), is a further indicator of the non-conforming nature of this practice.

Presenting what is suggested to be a Committee resolution during Members' Statements is not the proper course of procedure and I rule that such practice is out of order and should not occur in future. I invite the Standing Committee on Estimates and Financial Operations to lodge a written report on this matter, and any other matters it is inquiring into, to the House for its consideration in the acceptable form.
