- (c) what is the job title for each of these employees;
- (d) what entitlements do these employees receive (such as phone and vehicle entitlements); and
- (e) for each employee please provide an itemised breakdown for:
 - (i) phone entitlements; and
 - (ii) vehicle entitlements.

2922. Mr E.S. Ripper to the Minister for Water

- (1) Is potable water being used for dust suppression in the Baynton West subdivision in Karratha; and
 - (a) if yes, how much water has been used for the purpose; and
 - (b) if yes, for what period will that water be used?
- (2) Is potable water being used for dust suppression in any other subdivision in Karratha; and
 - (a) if yes, for which subdivisions;
 - (b) if yes, how much water has been used for the purpose; and

(c) if yes, for what period will that water be used?

- (1) When will the State Government budget for the purchase of land reserve for the planned Midland Freight Realignment as part of the Kewdale–Hazelmere Region Integrated Master Plan?
- (2) Has the Department of Planning made a decision as to a preferred route for the planned Midland Freight Realignment; and
 - (a) if yes, which route is preferred; and
 - (b) if no, when will a decision be made?
- (3) What steps will the Government take in the short-term to minimise noise and traffic issues related to the freight line in Midland/Woodbridge?
- (4) How does the Government plan to give emergency vehicles uninterrupted entry points to the Midland Health Campus from the town centre?

I refer to the *Towards Zero* Road Safety Strategy adopted by the Government last year, and I ask:

- (a) in view of that strategy, what measures, if any, have been taken by the Department of Main Roads to review and upgrade acceptable road standards;
- (b) has a business case been developed to focus on better safety outcomes for Western Australian roads based on safe system criteria; and
 - (i) if so, what will be done with that business case; and
 - (ii) if not, why not?
