Hon Kate Doust presented a petition from two petitioners requesting the Legislative Council to support the amendment of the State Administrative Tribunal Register of Proceedings 2011 in relation to Matter Number SAT CC 1258/2011 to remove any reference to section 11(1)(d) of the Act and the wording 'following a report of an investigation regarding a building service or HBWC complaint' and in its place correctly state on the Public Register under which provisions of the Act Matter Number SAT CC 1258/11 was validly transferred to the SAT. - (b) calls on the State Government to urgently re-examine Western Australia's current burn program and commit to a program of responsible and strategic controlled burns in order to protect lives, property and the forest biodiversity.
